ORDER VACATING CANCELLATION OF LICENSE AND REINSTATING LICENSE

On November 6, 2019, the Alcoholic Beverage Control Board (Board) cancelled the Wholesaler Class B License No. ABRA-112240 held by My Houseland, Inc., t/a My Houseland (Petitioner), because the Petitioner failed to pay the third year license fees for its License No. ABRA-112240 by September 30, 2019. *See* Board Order No. 2019-837.

On November 15, 2019, Constant Tchamda, on behalf of the Petitioneer sought reinstatement of the Wholesaler Class B License No. ABRA-112240. In support of her Request for Reinstatement, Ms. Tchamdstated stated that she missed the required payment of its third year license fees because she was not in United States when the Order to Cease and Desist was issued. She then recived the order cancelling her license on November 13, 2019.

The Board finds that the reinstatement of the license is proper conditioned upon the requirement that the Petitioner pays the required fees.

Accordingly, it is this 4th day of December, 2019, **ORDERED** that the **ORDER CANCELLING LICENSE** issued against My Houseland, Inc., t/a My Houseland, by the Board on November 6, 2019, be and hereby is **VACATED**.

IT IS FURTHER ORDERED that the Wholesaler Class B License No. ABRA-112240 be REINSTATED.

IT IS FURTHER ORDERED that the Petitioner pay the required fees within two (2) weeks from the date of this Order.

Pursuant to D.C. Official Code § 25-433(d)(1), any party adversely affected may file a Motion for Reconsideration of this decision within ten (10) days of service of this Order with the Alcoholic Beverage Regulation Administration, 2000 14th Street, N.W., Suite 400S, Washington, DC 20009.

Also, pursuant to section 11 of the District of Columbia Administrative Procedure Act, Pub. L. 90-614, 82 Stat. 1209, D.C. Official Code §2-510 (2001), and Rule 15 of the District of Columbia Court of Appeals, any party adversely affected has the right to appeal this Order by filing a petition for review, within thirty (30) days of the date of service of this Order, with the District of Columbia Court of Appeals, 430 E Street, N.W., Washington, D.C. 20001; (202/879-1010). However, the timely filing of a Motion for Reconsideration pursuant to 23 DCMR §1719.1 (2008) stays the time for filing a petition for review in the District of Columbia Court of Appeals until the Board rules on the motion. See D.C. App. Rule 15(b) (2004).
