## ORDER VACATING CANCELLATION OF LICENSE AND REINSTATING LICENSE

On November 18, 2020, the Alcoholic Beverage Control Board (Board) cancelled the Retailer Class CR License No. ABRA-112472 held by Officina Cafe, LLC, t/a Officina Café, because Officina Cafe, LLC failed to pay the second year license fees. See Board Order No. 2020-894.

On December 7, 2020, Officina Cafe, LLC (Petitioner), sought reinstatement of the Retailer's Class CR License No. ABRA-112472. In support of its request for reinstatement, the Petitioner indicated that all issues preventing the Petitioner from submitting its second year license fees have been resolved.

The Board finds that the reinstatement of the license is proper conditioned upon the requirement that the Petitioner pays the second year license fees.

Accordingly, it is this 9th day of December 2020, **ORDERED** that the **ORDER CANCELLING LICENSE** issued against the Petitioner, by the Board on November 18, 2020, be and hereby is **VACATED**.

**IT IS FURTHER ORDERED** that the Petitioner pay the required fees within two (2) weeks from the date of this Order.

Official Code §2-510 (2001), and Rule 15 of the District of Columbia Court of Appeals, any party adversely affected has the right to appeal this Order by filing a petition for review, within thi1ty (30) days of the date of service of this Order, with the District of Columbia Cou1t of Appeals, 430 E Street, N.W., Washington, D.C. 20001; (202/879-1010). However, the timely filing of a Motion for Reconsideration pursuant to 23 DCMR §1719.1 (2008) stays the time for filing a petition for review in the District of Columbia Court of Appeals until the Board rules on the motion. See D.C. App. Rule 15(b) (2004).
