3 CHAIRPERSON ANDERSON: All right. The  
4 next case on our calendar is Case No. 18-CMP-  
5 00222, Oki Bowl Ramen and Sake Bar, License No.  
6 107646.

7 Will the parties, please, approach and  
8 identify themselves for the record, please?

9 MR. SOUSA: Christopher Sousa for the  
10 District of Columbia.

11 CHAIRPERSON ANDERSON: Mr. Sousa.

12 MS. BOON-LONG: Hi. I'm Laddawan  
13 Boon-Long.

14 CHAIRPERSON ANDERSON: Ms. Boon-Long,  
15 good morning. All right. Are there any  
16 preliminary matters in this case?

17 MR. SOUSA: Yes. We have an Offer in  
18 Compromise to present to the Board.

19 CHAIRPERSON ANDERSON: And what is  
20 that, sir?

21 MR. SOUSA: As to Charge 1, no ABC  
22 manager on duty, that will be \$850 payable within

1 60 days or the license shall be suspended  
2 indefinitely until the fine is paid.

3 As to Charge 2, an increase in the  
4 interior occupancy, that will be \$4,500 payable  
5 within 60 days or the license shall be suspended  
6 indefinitely until paid.

7 CHAIRPERSON ANDERSON: All right. Ms.  
8 Boon-Long, it's my understanding that there is an  
9 Offer in Compromise and the Offer in Compromise  
10 is that for Charge 1, there is a fine of \$850  
11 payable in 60 days.

12 For Charge 2, there is a fine of  
13 \$4,500 payable in 60 days. If the fine is not  
14 payable in 60 days, the license will be suspended  
15 until the fine has been paid.

16 Is this your understanding of the  
17 Offer in Compromise?

18 MS. BOON-LONG: Yes.

19 CHAIRPERSON ANDERSON: Are you aware  
20 that by accepting an Offer in Compromise, that  
21 you are giving up your right to a hearing?

22 MS. BOON-LONG: Yes.

1                   CHAIRPERSON ANDERSON: Are you also  
2 aware that by accepting an Offer in Compromise,  
3 that you are giving up your right to appeal this  
4 matter?

5                   MS. BOON-LONG: Yes.

6                   CHAIRPERSON ANDERSON: With that said,  
7 I then make a motion that the Offer in Compromise  
8 of a fine of \$850 payable in 60 days for Charge  
9 1, the fine of \$4,500 payable in 60 days for  
10 Charge 2 and then if the total fine is not paid  
11 within 60 days, the license will be suspended  
12 until the fine has been paid. Is there a second?

13                   MEMBER CATO: Second.

14                   CHAIRPERSON ANDERSON: Mr. Cato has  
15 seconded the motion.

16                   All those in favor say aye.

17                   ALL: Aye.

18                   CHAIRPERSON ANDERSON: Those opposed?  
19 The matter passes 4-0-0.

20                   Ma'am, there is a sign-in sheet.  
21 Please sign your name on it, on that sheet. All  
22 right. Thank you.

1                   We will have you sign-off on some  
2 paperwork for this.

3                   MS. BOON-LONG: All right.

4                   CHAIRPERSON ANDERSON: All right. The  
5 Board will then be in recess until our 10:00  
6 hearing. All right. Okay. Thank you.
