ORDER VACATING CEASE AND DESIST

On November 1, 2023, the Alcoholic Beverage and Cannabis Board (Board) issued Board Order No. 2023-644 ordering 19th & K, Inc., t/a Ozio Martini & Cigar Lounge (Respondent), holder of a Retailer's Class CN License No. ABRA-117218, to stop selling, serving, or permitting the consumption of alcoholic beverages at the Respondent's establishment until payment of the second-year license fees and any associated fines are received by Alcoholic Beverage and Cannabis Administration (ABCA).

On November 14, 2023, the Respondent paid the license fees for the period of 2023 to 2024.

It is hereby **ORDERED** that the **ORDER TO CEASE AND DESIST** issued against the Respondent by the Board on November 1, 2023, pursuant to D.C. Official Code § 25-829 (2001), be and hereby is **VACATED**.
