MS. FLETCHER: Would the parties in the matter of the Park and 14th please come forward. This is Case number 19-PRO-00146, 920 14th Street, N.W., License number ABRA-07558.

This is a Class CN Retailer. This is the petition to amend or terminate the settlement agreement. The protest issues are adverse impact on peace, order, and quiet, residential parking, and vehicular and pedestrian safety, and real property values.

My name is LaVerne Fletcher, conducing the Roll Call Hearing as the Board's Agent.
