ORDER APPROVING OFFER IN COMPROMISE

The above-mentioned parties appeared before the Alcoholic Beverage Control Board on February 24, 2021. At the hearing, the parties proposed an offer-in-compromise (OIC) to resolve the enforcement action described in Case No. 20-CMP-00047. The Board approved the OIC at the hearing.

ORDER

Therefore, on this 24th day of February 2021, the Board **APPROVES** the OIC presented by the parties. The terms of the OIC are as follows:

1. The Respondent shall receive a **WARNING** for the alleged violations of D.C. Official Code § 25-726 (Charge I) and D.C. Official Code § 25-113(g)(1) (Charge II); and
2. The Respondent shall file a complete application for a Class Conversion with ABRA's Licensing Division within thirty (30) days from the date of this Order.

The ABRA shall deliver copies of this Order to the Government and the Respondent.

Pursuant to D.C. Official Code § 25-433(d)(1), any party adversely affected may file a Motion for Reconsideration of this decision within ten (10) days of service of this Order with the Alcoholic Beverage Regulation Administration, 2000 14th Street, N.W., Suite 400S, Washington, DC 20009.

Also, pursuant to section II of the District of Columbia Administrative Procedure Act, Pub. L. 90-614, 82 Stat. 1209, D.C. Official Code §2-510 (2001), and Rule 15 of the District of Columbia Court of Appeals, any party adversely affected has the right to appeal this Order by filing a petition for review, within thirty (30) days of the date of service of this Order, with the District of Columbia Court of Appeals, 430 E Street, N.W., Washington, D.C. 20001; (202/879- 1010). However, the timely filing of a Motion for Reconsideration pursuant to 23 DCMR §1719.1 (2008) stays the time for filing a petition for review in the District of Columbia Court of Appeals until the Board rules on the motion. See D.C. App. Rule 15(b) (2004).
