**ORDER CANCELLING LICENSE UNDER TITLE 23 OF THE DISTRICT OF
COLUMBIA MUNICIPAL REGULATIONS § 405.1**

The Alcoholic Beverage Regulation Administration (ABRA) has reviewed its records and determined that Penny Whisky Bar, LLC, t/a Penny Whisky Bar (Respondent), License No. ABRA-110402 was approved by the Alcoholic Beverage Control Board (Board) under Title 23 of the District of Columbia Municipal Regulations (DCMR) § 405.1, which authorized the Board to approve a license to an applicant before the issuance of a certificate of occupancy for the building in which the licensed premises shall be located.

ABRA records show that the Respondent has failed to renew its license by March 31, 2019, the deadline for renewal of all Retailer's Class CR licenses.

It is hereby **ORDERED** on this 15th day of May, 2019, that Penny Whisky Bar, LLC's License No. ABRA-110402 is **CANCELLED**. A copy of this Order shall be sent to the Respondent.

Pursuant to D.C. Official Code § 25-433(d)(1), any party adversely affected may file a Motion for Reconsideration of this decision within ten (10) days of service of this Order with the Alcoholic Beverage Regulation Administration, 2000 14th Street, N.W., Suite 400S, Washington, DC 20009.

Also, pursuant to section 11 of the District of Columbia Administrative Procedure Act, Pub. L. 90-614, 82 Stat. 1209, D.C. Official Code §2-510 (2001), and Rule 15 of the District of Columbia Court of Appeals, any party adversely affected has the right to appeal this Order by filing a petition for review, within thirty (30) days of the date of service of this Order, with the District of Columbia Court of Appeals, 430 E Street, N.W., Washington, D.C. 20001; (202/879-1010). However, the timely filing of a Motion for Reconsideration pursuant to 23 DCMR §1719.1 (2008) stays the time for filing a petition for review in the District of Columbia Court of Appeals until the Board rules on the motion. See D.C. App. Rule 15(b) (2004).
