And my position has always been this is your neighborhood. You live in the neighborhood. And so if you can come to an agreement, that's fine. If you can't come to an agreement, the Board will make a decision.

I don't have a problem making a decision, but I think sometimes if you make your own decision then both of you are happy. If the Board makes the decision, someone is going to be unhappy.

But we will be here to assist and associate whichever one it is. But if we have to have a protest hearing on August 7th at 4:30, then we will. And we will make a decision that I believe that hopefully both sides will, will be satisfied with if it goes that far.
