3 CHAIRPERSON ANDERSON: Alright. The  
4 next case in our calendar is Case No. 19-AUD-  
5 00085 for Po Boy Jim.

6 And Mr. Ortiz is already on the line.  
7 And Mr. -- I'm sorry, Ms. Andrews, I do not know  
8 if the licensee for Po Boy Jim is on the line.

9 MS. ANDREWS: Yes. One second, please.

10 Ms. Rebecca, you are -- you can enable  
11 your camera and your microphone.

12 (Pause.)

13 MS. ANDREWS: That's all, Mr. Chairman.

14 CHAIRPERSON ANDERSON: Good morning.  
15 The licensee, can you enable your camera? Do you  
16 have a camera on your phone?

17 MS. ANTOINE: Yes, I do.

18 CHAIRPERSON ANDERSON: Your camera --  
19 are you able to enable your video, please.

20 MS. ANTOINE: Okay. Hold on one  
21 second.

22 CHAIRPERSON ANDERSON: Thank you.

23 (Pause.)

24 MS. ANTOINE: Hold on. This -- I'm new  
25 to this. So, give me a minute. I'm sorry.

1 CHAIRPERSON ANDERSON: We're all new to  
2 this. So, you can take a minute, please.

3 MS. ANTOINE: Okay. But I'm here.

4 Is there someone that could tell me  
5 where do I enable the camera? Because I'm --  
6 once I click on it, I don't know what's going on.  
7 Hold on one second.

8 CHAIRPERSON ANDERSON: Do you see  
9 something that says: Start video? Can you click  
10 on that button, please.

11 MS. ANTOINE: Start video?

12 CHAIRPERSON ANDERSON: Yes. Do you see  
13 that on your --

14 MS. ANTOINE: I'm on my cell phone.  
15 So, I don't know if it makes a difference.

16 CHAIRPERSON ANDERSON: Alright. Well,  
17 if -- alright. I -- normally I ask folks to turn  
18 their video on.

19 But because I -- alright. Let's start  
20 and then I'll put something in the record. Let's  
21 start with the Government.

22 Can the Government please identify  
23 themselves for the record, please, and spell their  
24 name, please.

25 MR. ORTIZ: Stephen Ortiz on behalf of

1 the District of Columbia. That's Stephen, S-T-E-  
2 P-H-E-N. Ortiz, O-R-T-I-Z.

3 CHAIRPERSON ANDERSON: Good morning,  
4 Mr. Ortiz.

5 Ms. Antoine, can you please identify  
6 your name for the record, please, and please  
7 spell your first and last name, please.

8 MS. ANTOINE: Sure. I'm Rebecca  
9 Antoine -- A-N-T-O-I-N-E is the last name --  
10 owner of Po Boy Jim.

11 This is the one located at 709 Eighth  
12 Street, N.E. in Washington, D.C.

13 CHAIRPERSON ANDERSON: Alright. Thank  
14 you, Ms. Antoine.

15 And normally I ask that folks -- for  
16 video. But because you have appeared before me  
17 before, I do recognize your voice.

18 So, I can state that the person --  
19 because you have appeared before -- before me  
20 before and you have had -- and you do have a  
21 distinctive voice, I will verify that the person  
22 that we're speaking -- that is speaking on the  
23 phone who has represented themselves to the Board  
24 as the owner of Po Boy Jim, that this is actually  
25 the person although I am unable to see them.

1                    Alright. Mr. Ortiz, are there any  
2 preliminary matters in this case?

3                    MR. ORTIZ: There are no preliminary  
4 matters at this time.

5                    CHAIRPERSON ANDERSON: Alright. Thank  
6 you.

7                    And what -- because there are no  
8 preliminary matters, Ms. Antoine, this matter has  
9 been scheduled for a show cause hearing for a  
10 date to be determined.

11                   So, therefore, the ABC Board will  
12 provide you and Mr. Ortiz with a date and time  
13 for the show cause hearing.

14                   I would ask both parties to continue  
15 to speak so if there can -- if this matter can be  
16 settled prior to the hearing, then that would be  
17 appreciated.

18                   So, if there are no further questions  
19 or concerns, then I'm going to adjourn this  
20 hearing.

21                   Do you understand, Ms. Antoine?

22                   MS. ANTOINE: Yes, I do.

23                   CHAIRPERSON ANDERSON: Alright.

24                   MS. ANTOINE: I don't have any  
25 additional questions.

1                   CHAIRPERSON ANDERSON: Alright. Thank  
2 you very much and have a great day.

3                   MS. ANTOINE: You too. Thank you, uh-  
4 huh.

5                   (Whereupon, at 10:45 o'clock a.m. the  
6 hearing was concluded.)
