LUI: Good morning, John Lui on behalf of the District of Columbia. 13 14 CHAIR ANDERSON: Good morning, Mr. Lui. 15 Are there any preliminary matters in this case, 16 please? 17 MR. LUI: Yes, there is an offer in 18 compromise to present to the Board. 19 CHAIR ANDERSON: And what is that, sir? 20 MR. LUI: For Charge 1, the failure to 21 follow a settlement agreement, this is a second 22 tier violation, the offer in compromise is a \$500 23 fine, made payable within 30 days or its license 24 shall be suspended indefinitely until the fine is

paid.

CHAIR ANDERSON: Are you aware that by accepting an offer in compromise, that you're giving up your right to a hearing?

MR. MISKRI: Correct, I am.

CHAIR ANDERSON: Are you also aware that by accepting an offer in compromise, that you're giving up your right to appeal this matter?

MR. MISKRI: Yes, sir.

CHAIR ANDERSON: With that said, I make a motion that the offer in compromise of a fine of \$500 payable in 30 days be accepted. If the fine is not paid within 30 days, the license will be suspended until the fine has been paid. Is there a second?
