9 Assistant Attorney General, for the District of
10 Columbia.

12 Ms. Phillips.

13 MR. TUQABO: Azeria, A-Z-E-R-I-A, and
14 the last name is Tuqabo, T-U-Q-A-B-O.

15 CHAIRPERSON ANDERSON: I'm sorry, how
