3 CHAIRPERSON ANDERSON: All right. The
4 next case on our calendar is Case No. 19-AUD-
5 00019, Redrocks, License No. 90997.

6 Would the parties please approach and
7 identify themselves for the record, please?

8 MS. PHILLIPS: Louise Phillips,
9 Assistant Attorney General for the District of
10 Columbia.

11 CHAIRPERSON ANDERSON: Good morning,
12 Ms. Phillips.

13 MR. O'BRIEN: Good morning. James
14 O'Brien for RR4, doing business as Redrocks.

15 CHAIRPERSON ANDERSON: Mr. O'Brien?

16 MR. O'BRIEN: Yes.

17 CHAIRPERSON ANDERSON: What's your
18 relationship with the establishment, sir?

19 MR. O'BRIEN: I'm a managing member.

20 CHAIRPERSON ANDERSON: Okay. Thank
21 you.

22 All right. Are there any preliminary

1 matters in this case?

2 MS. PHILLIPS: Yes, Mr. Chair, there
3 is an Offer in Compromise that the parties would
4 like to present to the Board. That is a fine of
5 \$2,000 to be paid within 30 days or the license
6 will be suspended and that all quarterly
7 statements must be filed if they have not already
8 been filed.

9 CHAIRPERSON ANDERSON: Mr. O'Brien?

10 MR. O'BRIEN: Yes?

11 CHAIRPERSON ANDERSON: All right. It
12 is my understanding, sir, that there is an Offer
13 in Compromise and the Offer in Compromise is that
14 there is a fine of \$2,000 payable within 30 days,
15 that all outstanding quarterly statements should
16 be filed if they have not been filed. And the --
17 if the fine is not paid within 30 days, the
18 license will be suspended until the fine has been
19 paid. Is this your understanding of the Offer in
20 Compromise?

21 MR. O'BRIEN: Yes, that's my
22 understanding.

1 CHAIRPERSON ANDERSON: Are you aware
2 that by accepting an Offer in Compromise that
3 you're giving up your right to a hearing?

4 MR. O'BRIEN: Yes, I am.

5 CHAIRPERSON ANDERSON: Are you also
6 aware that by accepting an Offer in Compromise
7 that you're giving up your right to appeal this
8 matter?

9 MR. O'BRIEN: Yes, I do.

10 CHAIRPERSON ANDERSON: Hearing that,
11 I then make a motion that the Offer in Compromise
12 of a fine of \$2,000 to be payable in 30 days be
13 accepted, that all quarterly statements, if not
14 already filed, must be filed. If the fine is not
15 paid within 30 days, the license will be
16 suspended.

17 Is there a second?

18 MEMBER SHORT: Second.

19 CHAIRPERSON ANDERSON: Mr. Short has
20 seconded the motion. All those in favor, say
21 aye?

22 (Chorus of ayes)

1 CHAIRPERSON ANDERSON: Those opposed?

2 (No audible response.)

3 CHAIRPERSON ANDERSON: The matter
4 passes 4-0-0. Thank you very much. I'll have
5 you sign off on this paperwork, sir.

6 (Pause.)

7 CHAIRPERSON ANDERSON: All right.

8 MS. PHILLIPS: That concludes my list
9 of the statuses. Are there more?

10 CHAIRPERSON ANDERSON: No. Thank you.

11 MS. PHILLIPS: Okay.

12 CHAIRPERSON ANDERSON: Thank you, Ms.
13 Phillips. Have a good day.

14 MS. PHILLIPS: You, too.

15 (Whereupon, the above-entitled matter
16 went off the record at 9:45 a.m.)
