ORDER APPROVING OFFER-IN-COMPROMISE

The above-mentioned parties appeared before the Alcoholic Beverage Control Board on May 22, 2024 for a show cause hearing. At the hearing, the parties presented an Offer-in-Compromise (OIC) to resolve one or more charges described in the notices for these matter. The Board approved the OIC at the hearing.

ORDER

Therefore, on this 22nd day of May 2024, the Board **APPROVES** the OIC presented by the parties, which contains the following terms:

1. The Respondent voluntarily waives the right to present evidence, have a hearing, judicial review, or appeal of this matter;

2. The Respondent shall pay a fine totaling \$1,500 for both violations. The Respondent's investigative history shall reflect that the Respondent shall pay a \$750 fine for each secondary tier violation (D.C. Code § 25-701) based on its prior history of violations; and
3. All fines shall be paid within 30 days, or the license shall be immediately suspended until all fines are paid.

A copy of this Order shall be provided to the parties.

Pursuant to D.C. Official Code § 25-433(d)(1), any party adversely affected may file a Motion for Reconsideration of this decision within ten (10) days of service of this Order with the Alcoholic Beverage Regulation Administration, Reeves Center, 2000 14th Street, NW, 400S, Washington, D.C. 20009.

Also, pursuant to section 11 of the District of Columbia Administrative Procedure Act, Pub. L. 90-614, 82 Stat. 1209, D.C. Official Code § 2-510 (2001), and Rule 15 of the District of Columbia Court of Appeals, any party adversely affected has the right to appeal this Order by filing a petition for review, within thirty (30) days of the date of service of this Order, with the District of Columbia Court of Appeals, 430 E Street, N.W., Washington, D.C. 20001; (202-879-1010). However, the timely filing of a Motion for Reconsideration pursuant to 23 DCMR § 1719.1 stays the time for filing a petition for review in the District of Columbia Court of Appeals until the Board rules on the motion. *See* D.C. App. Rule 15(b) (2004).
