3 CHAIRPERSON ANDERSON: The next case  
4 is Case No. 17-CIT-00078. Again, Red Apron  
5 Butchery/The Partisan, License No. 90742.

6 Would the parties again identify  
7 themselves for the record?

8 MS. BABIN: Stephanie Babin, General  
9 Counsel.

10 CHAIRPERSON ANDERSON: Good morning  
11 again, Ms. Babin.

12 MS. SCHMIDT: Any Schmidt, Assistant  
13 Attorney General, on behalf of the District of  
14 Columbia.

15 CHAIRPERSON ANDERSON: Good morning  
16 again, Ms. Schmidt.

17 Are there any preliminary matters in  
18 this case?

19 MS. SCHMIDT: Yes, there is an Offer  
20 in Compromise of \$1,250 to be paid within 60 days  
21 or the license will be suspended until this  
22 payment is made.

1                   CHAIRPERSON ANDERSON: Thank you.  
2                   Again, Ms. Babin, it is my understanding that  
3                   there is an Offer in Compromise for a fine of  
4                   \$1,250 payable in 60 days. If the fine is not  
5                   payable in 60 days, the license will be suspended  
6                   until the fine has been paid.

7                   Is this your understanding of the  
8                   Offer in Compromise?

9                   MS. BABIN: Yes.

10                  CHAIRPERSON ANDERSON: Are you aware  
11                  that by accepting an Offer in Compromise, that  
12                  you are giving up your right to a hearing?

13                  MS. BABIN: Yes.

14                  CHAIRPERSON ANDERSON: Are you also  
15                  aware that by accepting an Offer in Compromise,  
16                  that you are giving up your right to appeal this  
17                  matter?

18                  MS. BABIN: Yes.

19                  CHAIRPERSON ANDERSON: With that said,  
20                  I then make a motion that the Offer in Compromise  
21                  of a fine of \$1,250 payable in 60 days be  
22                  accepted. If the fine is not payable in 60 days,

1 the license will be suspended until the fine has  
2 been paid.

3 Is there a second?

4 MEMBER SILVERSTEIN: Second.

5 CHAIRPERSON ANDERSON: Mr. Silverstein  
6 has seconded the motion.

7 All those in favor say aye.

8 ALL: Aye.

9 CHAIRPERSON ANDERSON: Those opposed?

10 The matter passes 6-0-0.
