ORDER GRANTING PETITIONER'S MOTION FOR RECONSIDERATION AND REINSTATEMENT OF LICENSE

On May 9, 2018, the Alcoholic Beverage Control Board (Board) cancelled the Retailer Class Caterer License ABRA-077045 held by Restaurant Associates, Inc., t/a Restaurant Associates, because Restaurant Associates, Inc. failed to pay the third year license fees for its license by March 31, 2018. *See* Board Order No. 2018-316.

On May 17, 2018, Jerry A. Moore III, Esq., on behalf of Restaurant Associates, Inc. (Petitioner), sought reinstatement of the Retailer's Class Caterer License ABRA-077045. In support of his Motion for Reconsideration, Mr. Moore stated that the Petitioner inadvertetly missed the required payment of its third year license fees.

The Board finds that the reinstatement of the license is proper conditioned upon the requirement that the Petitioner pays the required fees.

Accordingly, it is this 23rd day of May, 2018, **ORDERED** that the **ORDER CANCELLING LICENSE** issued against Restaurant Associates, Inc., t/a Associates, by the Board on May 9, 2018, be and hereby is **VACATED**.

IT IS FURTHER ORDERED that the Retailer Class Caterer License ABRA-077045 be REINSTATED.

IT IS FURTHER ORDERED that the Petitioner pay the required fees within two (2) weeks from the date of this Order.

Pursuant to D.C. Official Code § 25-433(d)(1), any party adversely affected may file a Motion for Reconsideration of this decision within ten (10) days of service of this Order with the Alcoholic Beverage Regulation Administration, 2000 14th Street, N.W., Suite 400S, Washington, DC 20009.

Also, pursuant to section 11 of the District of Columbia Administrative Procedure Act, Pub. L. 90-614, 82 Stat. 1209, D.C. Official Code §2-510 (2001), and Rule 15 of the District of Columbia Court of Appeals, any party adversely affected has the right to appeal this Order by filing a petition for review, within thirty (30) days of the date of service of this Order, with the District of Columbia Court of Appeals, 430 E Street, N.W., Washington, D.C. 20001; (202/879-1010). However, the timely filing of a Motion for Reconsideration pursuant to 23 DCMR §1719.1 (2008) stays the time for filing a petition for review in the District of Columbia Court of Appeals until the Board rules on the motion. See D.C. App. Rule 15(b) (2004).
