## ORDER VACATING CANCELLATION OF LICENSE AND REINSTATING LICENSE

On December 2, 2020, the Alcoholic Beverage Control Board (Board) issued Board Order No. 2020-995 cancelling RiRa Georgetown, LLC, t/a RiRa Irish Pub (Petitioner), License No. ABRA-092168.

Specifically, the Petitioner failed to pay the safekeeping fee for its License No. ABRA-092168 despite being notified by ABRA of the payment due date.

On June 3, 2021, Claran Sheehan, on behalf of the Petitioner, sought reinstatement of the Retailer's Class CR License No. ABRA-092168.

The Board finds good cause and that the reinstatement of the license is proper, with the condition that the Petitioner pays the required safekeeping fee.

Accordingly, it is this 9th day of June 2021, **ORDERED** that the **ORDER CANCELLING LICENSE** issued against the Petitioner by the Board on December 2, 2020, be and hereby is **VACATED**.

IT IS FURTHER ORDERED that its Retailer's Class CR License ABRA-092168 be REINSTATED.

**IT IS FURTHER ORDERED** that the Petitioner shall pay the required safekeeping fee within ten (10) days from the date of this Order.

Also, pursuant to section II of the District of Columbia Administrative Procedure Act, Pub. L. 90-614, 82 Stat. 1209, D.C. Official Code §2-510 (2001), and Rule 15 of the District of Columbia Court of Appeals, any party adversely affected has the right to appeal this Order by filing a petition for review, within thilty (30) days of the date of service of this Order, with the District of Columbia Coult of Appeals, 430 E Street, N.W., Washington, D.C. 20001; (202/879-1010). However, the timely filing of a Motion for Reconsideration pursuant to 23 DCMR §1719.1 (2008) stays the time for filing a petition for review in the District of Columbia Court of Appeals until the Board rules on the motion. See D.C. App. Rule 15(b) (2004).
