3 MS. FLETCHER: Would the parties in the
4 matter of Right Spot please come forward? The parties
5 in the matter of Right Spot. This is case number
6 19-PRO-00027, Meskerem Abebe?

7 MR. ABEBE: Abebe.

8 MS. FLETCHER: Thank you.

9 MR. ABEBE: I am the representative -- I
10 have the powers for attorney.

11 MS. FLETCHER: Okay. I'll take that.
12 That's the -- what is that? Your --

13 MR. ABEBE: Power of Attorney for my
14 sister.

15 MS. FLETCHER: Okay. Is that our copy?

16 MR. ABEBE: Yes.

17 MS. FLETCHER: Okay. I'll take it. I'll
18 take it. Thank you. Could you do me a favor? And
19 show that to Mr. Orlaskey for -- and then just bring
20 this --

21 MR. ABEBE: Okay.

22 MS. FLETCHER: -- back to me? Thank you.

1 Okay. Thank you. Thank you very much. Okay. Thank
2 you. If you would state your name and spell it for
3 the record, please?

4 MR. ABEBE: Thomas M. Abebe. T-H-O-M -A-
5 S, M dot, A-B-E-B-E.

6 MS. FLETCHER: Thank you very much. And
7 present on behalf of ANC1B?

8 MR. ORLASKEY: Dan Orlaskey, Commissioner,
9 ANC1B-02.

10 MS. FLETCHER: Thank you. ANC1B has
11 standing as a protester. We need to set a date for a
12 status hearing, protest hearing and a mediation. I'll
13 give you the date of the status and protest hearing
14 first.

15 The date for the status hearing is June
16 26th. That's June 26th at 9:30 a.m. The protest
17 hearing is scheduled for July 31st at 4:30 p.m. And
18 I should tell you, you'll get an official notice of
19 these dates.

20 MR. ORLASKEY: But before you go on, we
21 actually already have a completed settlement
22 agreement.

1 MS. FLETCHER: Okay.

2 MR. ORLASKEY: We just need to go through
3 the ANC vote to approve it and it's our draft. So I
4 don't see --

5 (Simultaneous speaking.)

6 MS. FLETCHER: And when does the ANC vote?

7 MR. ORLASKEY: Our next meeting's on the
8 6th. We can probably do it sooner, if that's
9 necessary. Not that we --

10 MS. FLETCHER: No. That --

11 MR. ORLASKEY: -- give it a vote.

12 MS. FLETCHER: So that'll be fine, Mr.
13 Orlaskey. What I'm going to do, I'm going to leave
14 the date for the status and protest hearing on the
15 record in case it doesn't work out. Although we
16 expect it to, but I won't set a date for mediation.

17 MR. ORLASKEY: Okay. That's fine. Thank
18 you.

19 MS. FLETCHER: So I'm not going to set a
20 date for mediation and once you get it signed, you can
21 submit it to Martha Jenkins, our general counsel.

22 MR. ORLASKEY: Uh-huh. Will do.

1 MS. FLETCHER: That's Martha, M-A-R-T- H-
2 A, J-E-N-K-I-N-S, martha.jenkins@anc.gov. And then,
3 we'll take it -- we'll put it on the Board's agenda
4 for approval --

5 MR. ORLASKEY: Okay.

6 MS. FLETCHER: -- and cancel the status
7 hearing and the protest hearing.

8 MR. ORLASKEY: Okay. Sounds good. Thank
9 you.

10 MS. FLETCHER: Thank you very much. Any
11 questions, Mr. Abebe?

12 MR. ABEBE: No.

13 MS. FLETCHER: Okay. Thank you very much.
14 Well, thank you for coming.

15 MR. ABEBE: Thank you.

16 MS. FLETCHER: The Roll Call Hearing is
17 concluded. Mr. Orlaskey, you've got one more.

18 MR. ORLASKEY: Got one more? Okay.
