20 MR. SOLLOSO: Thank you.

21 CHAIRPERSON ANDERSON: Can you,  
22 please, sign in? Sign your name in on the sign-

1 in sheet, sir.

2 Is there -- are there any preliminary  
3 matters in this case?

4 MS. PHILLIPS: It's my understanding  
5 that this owner had a counsel and the counsel  
6 asked --

7 CHAIRPERSON ANDERSON: Oh, you know
