of the offer in compromise? 1 2 MS. MAXWELL RIDORE: It is. 3 CHAIRPERSON ANDERSON: Is your client 4 aware that by accepting an offer in compromise 5 that they are giving up their right to a hearing? 6 7 MS. MAXWELL RIDORE: Yes. 8 CHAIRPERSON ANDERSON: Are they also 9 aware that by accepting an offer in compromise 10 that they're giving up their right to appeal 11 this matter? 12 MS. MAXWELL RIDORE: Yes. CHAIRPERSON ANDERSON: With this 13 14 said, I then make a motion that the offer in 15 compromise of a fine of \$350 payable within 30 16 days be accepted. 17 If the fine is not paid within 30 18 days, the license will be suspended until the 19 fine has been paid. 20 Is there a second? 21 MEMBER CROCKETT: Second. 22 CHAIRPERSON ANDERSON: Ms. Crockett 23 has seconded the motion. All those in favor, 24 say aye. 25 (Chorus of ayes.)
