## ORDER ON DISMISSAL OF THE GROUP OF FIVE INDIVIDUALS' PROTEST

The Application filed by Wyoming Cube & Bale, LLC, t/a Sandbox Restaurant, for a New Retailer's Class CR License, having been protested, came before the Alcoholic Beverage Control Board (Board) for a Roll Call Hearing on December 17, 2018, in accordance with D.C. Official Code § 25-601 (2001). in order to be granted standing as A Group of Five Individuals. The Group of Five Individuals was originally granted conditional standing at the Roll Call Hearing.

On January 16, 2019, the Board dismissed the Protest of the Group of Five Individuals because five (5) individuals failed to appear at the Protest Status Hearing, in accordance with the Title 23 of the District Columbia Municipal Regulations § 1603.3. The Group of Five Individuals may file a Request for Reinstatement with the Board within ten (10) days from the date of this Order.

## ORDER

The Board does hereby this 16th day of January, 2019, **DISMISS** the Protest of the Group of Five Individuals. The Board advises the parties that the protests of ANC 2E, CAG, and the Group of Seven Individuals, remain, and the Protest Hearing is set for February 13, 2019 at 1:30 p.m.
