4 next case on our calendar is Case No. 18-CMP-  
5 00060, Scion Restaurant, License No. 82174.

6 Will the parties, please, approach and  
7 identify themselves for the record, please?

8 MS. SCHMIDT: Good morning. Amy  
9 Schmidt, Assistant Attorney General, on behalf of  
10 the District of Columbia.

11 CHAIRPERSON ANDERSON: Good morning,  
12 Ms. Schmidt.

13 MS. LIU: Joanne Liu, owner of Scion  
14 Restaurant.

15 CHAIRPERSON ANDERSON: I'm sorry,  
16 what's your last name again, ma'am?

17 MS. LIU: Liu, L-I-U.

18 CHAIRPERSON ANDERSON: Good morning,  
19 Ms. Liu.

20 All right. Are there any preliminary  
21 matters in this case?

22 MS. SCHMIDT: Yes. Yes, there is an

1 Offer in Compromise consisting of a \$2,000 fine  
2 to be paid within 60 days. If that fine is not  
3 paid within 60 days, the license will be  
4 suspended until the fine is paid.

5 CHAIRPERSON ANDERSON: Ms. Liu, it's  
6 my understanding there is an Offer in Compromise  
7 of a fine of \$2,000 payable in 60 days. If the  
8 fine is not payable in 60 days, the license will  
9 be suspended until the fine has been paid.

10 Is this your understanding of the  
11 Offer in Compromise?

12 MS. LIU: It is.

13 CHAIRPERSON ANDERSON: Are you aware  
14 that by accepting an Offer in Compromise, that  
15 you are giving up your right to a hearing?

16 MS. LIU: I am.

17 CHAIRPERSON ANDERSON: Are you also  
18 aware that by accepting an Offer in Compromise,  
19 that you are giving up your right to appeal this  
20 matter?

21 MS. LIU: I am.

22 CHAIRPERSON ANDERSON: Hearing that,

1 I then make a motion that the Offer in Compromise  
2 of a fine of \$2,000 payable in 60 days be  
3 accepted. Is there a second?

4 MEMBER SHORT: Second.

5 CHAIRPERSON ANDERSON: Mr. Short has  
6 seconded the motion.

7 All those in favor say aye.

8 ALL: Aye.

9 CHAIRPERSON ANDERSON: Those opposed?  
10 The matter passes 6-0-0.

11 I will have you sign-off on this OIC  
12 form, Ms. Liu. And you have 60 days to pay the  
13 fine. Thank you very much. I thank the parties  
14 for coming to an agreement in this matter.
