MS. FLETCHER: Are the parties present in the matter of Secret Lounge, Secret Lounge? Parties in the matter of Secret Lounge. This is Case Number 19-PRO-00119, Eleana, LLC 1928 9th Street, N.W., License Number ABRA-107123. This is a license renewal.
