At the status hearing at 15 least five of them will need to appear in person 16 in order for the board to grant full standing. 17 Also, Ms. Verdi, I was going to grant 18 conditional standing, because I need you to 19 provide the unit numbers for each of your 20 protestants. 21 So the letter does name the address, 22 one for residents at the Adele condominium and one for the Presidential. 23 24 And all of their names are there, and 25 all of their names are listed under the

appropriate condominium, but I need them to write 1 2 their addresses, and particularly their unit 3 number, so that we have the full address for each 4 person. 5 So if you could do that at the same time that the board grants you conditional stand 6 7 -- grants you standing, because five people are 8 present, you provide that information you'll also 9 be granted full standing. 10 Any questions about that at all? 11 MS. VERDI: Thank you. No. 12 MS. FLETCHER: Okay. You're welcome. 13 Okay. And so we have conditional 14 standing granted to the group of 19. 15 The group of 19 is the only protestant 16 in this matter. 17 I'm going to give you the next 18 available date for mediation, we'll provide you with the dates of the upcoming status and protest 19 20 hearing at a later date. 21 But for today, I'm going to give you 22 the next available day for mediation. 23 Okay.
