## ORDER VACATING CANCELLATION OF LICENSE AND REINSTATING LICENSE

On April 3, 2024, the Alcoholic Beverage and Cannabis Board (Board) issued Board Order No. 2024-151 cancelling Naomi's Ladder II, LLC, t/a Smokin' Pig (Petitioner), License No. ABRA-104866.

Specifically, the Petitioner failed to pay the safekeeping fees for its License No. ABRA-104866 despite being notified by Alcoholic Beverage and Cannabis Administration (ABCA) of the payment of fees.

On April 12, 2024, Cynthia Gibson, on behalf of the Petitioner, sought reinstatement of the Retailer's Class CT License No. ABRA-104866. In support of the Request for Reinstatement, the Petitioner indicated that they did not receive the safekeeping fees notification.

The Board finds good cause and that the reinstatement of the license is proper with the condition that the Petitioner pays the required safekeeping fees.

Accordingly, it is this 24 day of April 2024, **ORDERED** that the **ORDER CANCELLING LICENSE** issued against the Petitioner by the Board on April 3, 2024, be and hereby is **VACATED**.

**IT IS FURTHER ORDERED** that its Retailer's Class CT License ABRA-104866 be **REINSTATED**.

**IT IS FURTHER ORDERED** that the Petitioner shall pay the required safekeeping fees within ten (10) days from the date of this Order.

Pursuant to D.C. Official Code § 25-433(d)(1) (applicable to alcohol matters) or 22-C DCMR § 9720 (applicable to medical cannabis matters), any party adversely affected may file a Motion for Reconsideration of this decision within ten (10) days of service of this Order with the Alcoholic Beverage and Cannabis Administration, 2000 14<sup>th</sup> Street, N.W., Suite 400S, Washington, DC 20009.

Also, pursuant to section II of the District of Columbia Administrative Procedure Act, Pub. L. 90-614, 82 Stat. 1209, D.C. Official Code § 2-510 (2001), and Rule 15 of the District of Columbia Court of Appeals, any party adversely affected has the right to appeal this Order by filing a petition for review, within thirty days of the date of service of this Order, with the District of Columbia Court of Appeals, 430 E Street, N.W., Washington, D.C. 20001 (202/879- 1010). However, the timely filing of a Motion for Reconsideration stays the time for filing a petition for review in the District of Columbia Court of Appeals until the Board rules on the motion. *See* D.C. App. Rule 15(b) (2004).
