3 CHAIRPERSON ANDERSON: The next case
4 on our calendar is Case No. 18-CMP-00160, Sticky
5 Rice, License No. 72783.

6 Would the parties, please, approach
7 and identify themselves for the record, please?

8 MS. PHILLIPS: Louise Phillips,
9 Assistant Attorney General, for the District of
10 Columbia.

11 CHAIRPERSON ANDERSON: Ms. Phillips.

12 MS. YOHANNES: Good morning. Sidon
13 Yohannes on behalf of the licensee.

14 CHAIRPERSON ANDERSON: Good morning,
15 Ms. Yohannes.

16 Ms. Phillips, are there any
17 preliminary matters in this case?

18 MS. PHILLIPS: Yes, Mr. Chair. The
19 parties have reached an Offer in Compromise that
20 they wish to present to the Board. This is a
21 three charge matter.

22 The first charge is \$1,500 to be paid

1 within 30 days.

2 Charge 2 is dismissed, as already
3 included in Charge 1.

4 And Charge 3 is a mandatory warning.

5 CHAIRPERSON ANDERSON: Good morning,
6 Ms. Yohannes. It's my understanding that there
7 is an Offer in Compromise and the Offer in
8 Compromise is that for Charge 1 there is a \$1,500
9 fine payable in 30 days. If the fine is not
10 payable in 30 days, the license will be suspended
11 until the fine has been paid.

12 Charge 2 has been dismissed and for
13 Charge 3 there is a mandatory warning.

14 Is this your understanding of the
15 Offer in Compromise?

16 MS. YOHANNES: Yes.

17 CHAIRPERSON ANDERSON: Is your client
18 aware that by accepting an Offer in Compromise,
19 that they are giving up their right to a hearing?

20 MS. YOHANNES: Yes.

21 CHAIRPERSON ANDERSON: Is your client
22 also aware that by accepting an Offer in

1 Compromise, that they are giving up their right
2 to appeal this matter?

3 MS. YOHANNES: Yes.

4 CHAIRPERSON ANDERSON: With this said,
5 I then make a motion that the Offer in Compromise
6 for Sticky Rice of a fine of \$1,500 payable in 30
7 days. If the fine is not payable in 30 days, the
8 license will be suspended until the fine has been
9 paid. Charge 2 has been dismissed and Charge 3 a
10 mandatory warning be issued.

11 Is there a second?

12 MEMBER SHORT: Second.

13 CHAIRPERSON ANDERSON: Mr. Short has
14 seconded the motion.

15 All those in favor say aye.

16 ALL: Aye.

17 CHAIRPERSON ANDERSON: Those opposed?

18 The matter passes 4-0-0.

19 Thank you very much.

20 MS. YOHANNES: Thanks.
