3 CHAIRPERSON ANDERSON: All right. The  
4 next case on our calendar is Case No. 19-AUD-  
5 00021, Sing Sing Karaoke, License No. 73783.

6 Would the parties, please, approach  
7 and identify themselves for the record, please?

8 MR. MARTIN: Jason Martin for Sing  
9 Sing Karaoke.

10 CHAIRPERSON ANDERSON: Good morning,  
11 Mr. Martin.

12 MR. MARTIN: Good morning.

13 MS. PHILLIPS: Good morning, Louise  
14 Phillips, Assistant Attorney General, for the  
15 District of Columbia.

16 CHAIRPERSON ANDERSON: Good morning,  
17 Ms. Phillips.

18 Are there any preliminary matters in  
19 this case?

20 MS. PHILLIPS: Yes, indeed there are.  
21 The parties have an Offer in Compromise to  
22 present to the Board. There will be a fine of

1       \$2,000 to be paid within 90 days. And the  
2       quarterly statements must be submitted, if they  
3       have not already been done, done so, if it has  
4       not been done so.

5                   CHAIRPERSON ANDERSON: All right. Mr.  
6       Martin, good morning. Again, it's my  
7       understanding that there is an Offer in  
8       Compromise and the Offer in Compromise is that  
9       there is a fine of \$2,000 payable within 90 days.  
10      That whatever outstanding statements, quarterly  
11      statements, if they have not been submitted, they  
12      should be submitted. And if the fine is not  
13      payable within 90 days, the license will be  
14      suspended until the fine has been paid.

15                   Is this your understanding, sir, of  
16      the Offer in Compromise?

17                   MR. MARTIN: Yes.

18                   CHAIRPERSON ANDERSON: Are you aware  
19      that by accepting an Offer in Compromise, that  
20      you are giving up your right to a hearing?

21                   MR. MARTIN: Yes.

22                   CHAIRPERSON ANDERSON: And you are

1 also aware that by accepting an Offer in  
2 Compromise, that you are giving up your right to  
3 appeal this matter?

4 MR. MARTIN: Yes.

5 CHAIRPERSON ANDERSON: With that said,  
6 I then make a motion that the Offer in Compromise  
7 of a fine of \$2,000 payable within 90 days be  
8 accepted. If the fine is not payable within 90  
9 days and also a part of the agreement is that all  
10 outstanding statements will be filed, so if the  
11 fine is not payable within 90 days, the license  
12 will be suspended until the fine has been paid.  
13 Is there a second?

14 MEMBER SILVERSTEIN: Second.

15 CHAIRPERSON ANDERSON: Mr. Silverstein  
16 has seconded the motion.

17 All those in favor say aye.

18 ALL: Aye.

19 CHAIRPERSON ANDERSON: Those opposed?

20 The matter passes 5-0-0.

21 We will have you sign-off on some  
22 paperwork shortly, sir. Thank you.
