an offer in compromise, so all right. Let me --1 2 and I'm going to let you know what I need to get 3 from you, hopefully, by close of business today. All right. It's my understanding 4 5 there's an offer in compromise and the offer in compromise is that there is a fine of \$350, 6 7 payable within 30 days. If the fine is not paid 8 within 30 days, the license will be suspended. 9 Is this your understanding of the offer in 10 compromise? 11 MR. (Chorus of ayes) 6 7 CHAIRPERSON ANDERSON: Those opposed. 8 The matter passes 4-0-0. What I also need you to 9 do, Mr. Banks, is for you to provide this agency, 10 hopefully by close of business today, with a 11 letter authorizing you to represent the agency. 12 MR. BANKS: Sure. 13 CHAIRPERSON ANDERSON: I do not want 14 for you to be here and then because on my 15 records, it has Robert Blair as the president, 16 who's on the license, and Mr. Blair can, at some 17 point, say, I don't know who Mr. Banks is. Mr. 18 Banks showed up, made representation, and he 19 wasn't authorized to do that, so I'm not going to 20 pay the fine. 21 So we need to get that information 22 from you by -- on the letterhead from the agency 23 saying that you can represent this establishment, 24 and as a general matter, I would say, since you 25 have stated that you have always done that --
