4 on our calendar is Case No. 18-CMP-00223, Sushi
5 Keiko, License No. 94610.

6 Will the parties, please, approach and
7 identify themselves for the record, please?

8 MR. HUANG: Good morning, Mr.
9 Anderson. My name is Ferry Huang. I'm the
10 current owner of Sushi Keiko.

11 CHAIRPERSON ANDERSON: Good morning,
12 Mr. Huang.

13 MR. ZHANG: My name is Wei Zhang. I'm
14 for -- also owner.

15 CHAIRPERSON ANDERSON: All right.
16 Good morning. And I remember -- all right.

17 MR. ZHANG: Yeah.

9 application, I hope this is moving through its
10 process.

11 MR. HUANG: This morning it finish,
12 yeah. We spoke a little bit with Ms. Louise
13 Phillips.

14 CHAIRPERSON ANDERSON: All right.

15 MR. HUANG: We explain all the
16 situation, so I was wondering what's the status
17 of, you know, the --

18 CHAIRPERSON ANDERSON: Well, the
19 reason I said it is because I remember we had a
20 Fact-Finding Hearing on this regarding the
21 ownership, so I'm just saying since the parties
22 are here in front of me, I hope that we are

1 moving along.

2 But whatever agreement is between the
3 Government and the licensee, the new licensee or
4 the transferee, the Board will move forward. So
5 you and Ms. Phillips can continue having
6 conversations and we will see what happens if we
7 have a hearing on the 27th. Okay?

8 MR. HUANG: Okay.

9 CHAIRPERSON ANDERSON: All right.

10 Thank you.

11 MR. HUANG: Got it. Thank you. Do I
12 need to --

13 CHAIRPERSON ANDERSON: That's it.

14 Just sign-in and then you are free to go.
