3 CHAIRPERSON ANDERSON: Good morning,
4 everyone. I would like to welcome you to the
5 regularly scheduled meeting of the District of
6 Columbia Alcoholic Beverage Control Board.
7 Please know that today's hearings will be
8 conducted in accordance with D.C. Official Code
9 Section 2-574 of the Open Meetings Act.

10 Today is February 28, 2018. I would
11 first like to introduce Members of the Board with
12 us today. To my far left is Mr. -- I'm sorry, to
13 my far right is Mr. Bobby Cato. To my immediate
14 right is Mr. Nick Alberti. To my far left is Mr.
15 Mike Silverstein and to my immediate left is Mr.
16 James Short.

17 My name is Donovan Anderson. I'm
18 Chairman of the Board. We have five Members in
19 attendance today and we do have a quorum.

20 I would like to mention two things
21 before we first get started. First of all, if
22 you have any electronic devices, pagers, cell

1 phones or such, please, make certain that they
2 are turned off to avoid any interruption of the
3 proceedings.

4 Secondly, there is a piece of paper on
5 each table. When you come forward as your case

11 aloud for the court reporter.

12 I will note that the approximate time
13 is 9:47. I apologize that we are running late
14 this morning, but at 9:30 it didn't appear anyone
15 was out here. And the monitor back there was --
16 is not working, so I couldn't gauge who was here.
17 So I appreciate the fact that you are here, that
18 for the folks who were here on time, and I don't
19 want to let you know that -- I don't want you to
20 think that we do not appreciate your time to be
21 here.

22 All right. So let's move on with our

3 Bar Illusion, License No. 108315.
