3 AGENT FLETCHER: Would the parties in
4 the matter of TLT, please come forward? This is
5 Case Number 18-PRO-00005, Bar Illusion LLC, 5213
6 Georgia Avenue NW, License Number ABRA-108315.
7 This is a retailer Class CT new application.

8 The protest issues are adverse impact
9 on peace, order and quiet, residential parking,
10 and vehicular and pedestrian safety and real
11 property values.

12 My name is La Verne Fletcher. I'm
13 conducting the Roll Call Hearing as the Board's
14 Agent. Introductions beginning with the
15 applicant please.

16 MR. HAILU: Yes. My name is Leul
17 Hailu, L-E-U-L and last name H-A-I-L-U, the owner
18 of Bar Illusion.

19 AGENT FLETCHER: Thank you. And
20 present on behalf of ANC 4D?

21 MR. BARDEN: Jamie Barden, ANC 4DO4.
22 That's Barden, B-A-R-D-E-N, Jamie, J-A-M-I-E.

1 AGENT FLETCHER: Thank you. Mr.
2 Barden, is your contact information -- could you
3 put your contact information on that sheet or did
4 you already?

5 MR. BARDEN: It is actually full.

6 AGENT FLETCHER: You can just flip it
7 over. Everyone didn't need to sign but everyone
8 did. I only really needed the designated
9 representatives. Any space you find, you can
10 write it, I'll find it.

11 MR. BARDEN: Okay.

12 AGENT FLETCHER: Is anyone present
13 from the group of eight?

14 MR. BARDEN: I will also be
15 representing the group of eight.

16 AGENT FLETCHER: Okay.

17 MR. BARDEN: I'm on the letter as a
18 representative.

19 AGENT FLETCHER: Okay, thank you.
20 Yes, you are. The group of eight will be granted
21 conditional standing because you're here today,
22 Mr. Barden. At the protest hearing, each -- at

1 least four of the members from the group will
2 need to be present or the board may dismiss the
3 protest. But for the purpose of the roll call
4 hearing, ANC 4D has standing and the group of
5 eight is granted conditional standing.

6 The date for the protest hearing in
7 this matter is March the 28th. It's March the
8 28th at 1:30.

9 MR. HAILU: 28th at 1:30?

10 AGENT FLETCHER: It's on a Wednesday.

11 A status hearing is going to be scheduled but
12 that date is not available to me today and so
13 when you receive your hearing notice, the date
14 for the status hearing will be on it. I'll give
15 you the next available date for mediation, which
16 we also need to schedule.

17 MR. BARDEN: We had a conversation
18 about our availability if I could -- things for
19 you.

20 AGENT FLETCHER: Yes. Yes.

21 MR. BARDEN: Is -- do you have things
22 February 21st?

1 AGENT FLETCHER: The 21st?

2 MR. BARDEN: Yes.

3 AGENT FLETCHER: Yes, that date is
4 available.

5 MR. BARDEN: And it would be in the
6 morning?

7 AGENT FLETCHER: That's available too.

8 MR. BARDEN: Okay.

9 AGENT FLETCHER: Time?

10 MR. BARDEN: I'll now turn it over to
11 you --

12 AGENT FLETCHER: Okay, well then --

13 MR. BARDEN: Like, I don't know, 10
14 o'clock?

15 MR. HAILU: Yes, that's good.

16 AGENT FLETCHER: 10:00 is good.

17 MR. BARDEN: Okay.

18 AGENT FLETCHER: Mediation is
19 scheduled for Wednesday, February 21st at 10:00.
20 Mr. Hailu, I think I saw you put your contact
21 information on that sheet all ready?
