therefore the board will issue an order

16	that everything is up to par, basically, and
17	that she's okay
18	MEMBER SILVERSTEIN: Can you speak
19	up louder?
20	MR. MARTINEZ: She wanted to make
21	sure that everything's up to par and that she
22	shows up. She originally thought that I can

come in because one of my sister's is having a 1 2 baby, so she was at the hospital, so she wasn't able to come in. 3 4 CHAIRPERSON ANDERSON: Well, I thank 5 you for -- and congratulations -- and thank you 6 for taking the time and effort to come back. 7 You didn't have to come back. You showed more 8 respect for this board than the previous hearing 9 that we just had. And I'm serious, is that you 10 sent your son, so you can say that you were 11 represented here this morning. And we just had 12 another establishment and they did not show up. 13 So I want to thank you for showing this board 14 that you do appreciate the work that we do. 15 MR. MARTINEZ: She says thank you 16 very much. 17 CHAIRPERSON ANDERSON: And that you 18 left the hospital with your grandchild to be 19 here today. 20 MS. ALVARADO: Thank you. 21 CHAIRPERSON ANDERSON: So thank you And there's also some good news 22 very much.
