5 because this matter appears to be going to a Show
6 Cause Hearing, and so one of the problems that I
7 have been having is that when we have a Show
8 Cause Hearing, the attorneys they do not disclose
9 documents and that is in our regulations that at
10 least seven days before the hearing, if you are
11 going to -- whatever documents or witnesses you
12 are going to rely upon, it needs to be disclosed
13 to the Agency and the other side.

14 So this is something that I will do
15 routinely to let folks know when we have our Show
16 Cause Hearings that you need to disclose your
17 documents and witnesses. So if you have -- I
18 have had cases where there are recordings and
19 folks are showing up the first day and neither
20 side has had the recording.

21 So I just want you to know that this
22 is the expectation that you disclose these

1 documents to each side and to ABRA at least seven
2 days before the hearing. Okay? All right.

3 Thank you.

4 MS. YOHANNES: Understood. Thank you.
