CHAIRPERSON ANDERSON: Good morning, everyone. I would like to welcome you to the regularly scheduled meeting of the District of Columbia Alcoholic Beverage Control Board.

Today is March 11, 2020, and before we start, we have a new member. So, we have Mr. Steve Walker, from the Mayor's Office of Talent and Acquisitions, from the MOTA Office. We'll swear him in this morning.

10 My name is Donovan Anderson, I'm
11 Chairman of the Board. We have seven members in
12 attendance today. We do have a quorum and I've
13 been chair for five years, and I believe that in
14 the five years I've been here, there's only been
15 a very short period of time that we have had
16 seven members on the board.

17 So, I do look forward to working with
18 all seven members of the board.
