9	MR. RIVERO: Good morning, Board
10	Members. Fernando Rivero for the District of
11	Columbia.
12	CHAIRPERSON ANDERSON: Good morning,
13	Mr. Rivero.
14	MR. JABLONSKI: Gaynor Jablonski,
15	owner Ugly Mug.
16	CHAIRPERSON ANDERSON: Good morning,
17	Mr. Jablonski. If I butcher your name, let me
18	know, please.
19	MR. JABLONSKI: You got it. No, you
20	got it.
21	CHAIRPERSON ANDERSON: Okay. Thank
22	you. All right. Are there any preliminary

matters in this case, Mr. Rivero? 1 2 MR. RIVERO: Yes. The parties have an Offer in Compromise to present to the Board, at 3 this time, and the offer consists of a fine of 4 5 \$2,000 payable in 60 days. If the fine is not 6 paid in 60 days, the license will be suspended 7 until payment is received. 8 CHAIRPERSON ANDERSON: Thank you. 9 MR. RIVERO: That's the Offer in Compromise. 10 11 CHAIRPERSON ANDERSON: Mr. Jablonski, 12 it's my understanding that there is an Offer in Compromise and the Offer in Compromise is that 13 14 there is a fine of \$2,000 payable in 60 days. Ιf 15 the fine is not payable in 60 days, the license 16 will be suspended until the fine has been paid. 17 Is this your understanding of the 18 Offer in Compromise? 19 MR. JABLONSKI: Yes, it is. 20 CHAIRPERSON ANDERSON: Are you aware 21 that by accepting an Offer in Compromise, that

you are giving up your right to a hearing?

22	sign-off on some paperwork.
