**ORDER APPROVING REQUEST TO EXTEND A TEMPORARY  
OPERATOR’S RETAIL PERMIT**

---

On May 15, 2024, the Board approved a request filed by The Upper Room DC, LLC, t/a The Upper Room DC (Applicant) for a Temporary Operator’s Retail Permit (TORP) in accordance with 23 D.C. Municipal Regulations (DCMR) § 201.

Per 23 DCMR § 201.5, “Notwithstanding § 201.4, no temporary operating retail permit shall be valid for longer than ninety (90) calendar days unless extended by the Board for good cause.”

On January 8, 2025, the Applicant has filed a request to extend the TORP permit. The Applicant has demonstrated good cause for the Board to extend the TORP permit for an additional ninety (90) days.

The Alcoholic Beverage and Cannabis Board does hereby this 15th day of January 2025, **APPROVES** the Applicant’s request to extend the TORP permit and the TORP permit is now set to expire on April 15, 2025.

Pursuant to 23 DCMR §9723.1 (2003) any party adversely affected may file a Motion for Reconsideration of this decision within ten (10) days of service of this Order with the Alcoholic Beverage and Cannabis Administration, 2000 14<sup>th</sup> Street, N.W., Suite 400S, Washington, DC 20009.

Also, pursuant to section II of the District of Columbia Administrative Procedure Act, Pub. L. 90-614, 82 Stat. 1209, D.C. Official Code §2-510 (2001), and Rule 15 of the District of Columbia Court of Appeals, any party adversely affected has the right to appeal this Order by filing a petition for review, within thirty (30) days of the date of service of this Order, with the District of Columbia Court of Appeals, 430 E Street, N.W., Washington, D.C. 20001; (202/879- 1010). However, the timely filing of a Motion for Reconsideration pursuant to 23 DCMR §1719.1 (2008) stays the time for filing a petition for review in the District of Columbia Court of Appeals until the Board rules on the motion. See D.C. App. Rule 15(b) (2004).
