ORDER VACATING CANCELLATION OF LICENSE AND REINSTATING LICENSE

On November 18, 2020, the Alcoholic Beverage Control Board (Board) cancelled the Retailer Class CR License No. ABRA-102914 held by Quintanilla Foods, LLC, t/a Tony's Place (Petitioner), because the Petitioner failed to pay the second year license fees. *See* Board Order No. 2020-877.

On February 3, 2021, Etelvina Quintanilla, on behalf of the Petitioner, sought reinstatement of the Retailer's Class CR License No. ABRA-102914. In support of its request for reinstatement, the Petitioner indicated that all issues preventing the Petitioner from submitting its second year license fees have been resolved.

The Board finds that the reinstatement of the license is proper conditioned upon the requirement that the Petitioner pays the second year license fees.

Accordingly, it is this 24th day of February 2021, **ORDERED** that the **ORDER CANCELLING LICENSE** issued against the Petitioner, by the Board on November 18, 2020, be and hereby is **VACATED**.

IT IS FURTHER ORDERED that the Petitioner pay the required fees within two (2) weeks from the date of this Order.
