3 CHAIRPERSON ANDERSON: All right. We  
4 are back on the record. Our next case is Case  
5 No. 18-CC-00108, Trump International Hotel  
6 Washington, D.C., License No. 100648.

7 Will the parties, please, approach and  
8 identify themselves for the record, please?

9 MS. PHILLIPS: Good morning, Board  
10 Members. Louise Phillips, Assistant Attorney  
11 General for the District of Columbia. And Happy  
12 New Year.

13 CHAIRPERSON ANDERSON: Good morning  
14 and Happy New Year, Ms. Phillips.

15 MR. O'BRIEN: Stephen O'Brien for the  
16 respondent accompanied by Mickael Damelincourt,  
17 who is the general manager of the Trump  
18 International Hotel.

19 CHAIRPERSON ANDERSON: All right.  
20 Good morning, Mr. O'Brien. And I did not get the  
21 name.

22 MR. O'BRIEN: Mickael Damelincourt.

1 The reporter has his business card.

2 CHAIRPERSON ANDERSON: Well, I -- go  
3 ahead, sir.

4 MR. DAMELINCOURT: You did a good job  
5 pronouncing it. Mickael Damelincourt.

6 CHAIRPERSON ANDERSON: All right. So  
7 I'll go with Mr. O'Brien's interpretation of your  
8 name. I apologize. I try to -- I, myself, try  
9 to pronounce all the names, but I don't think I'm  
10 going to try that one.

11 MR. DAMELINCOURT: Try to tell my  
12 kids, who are married, how to pronounce it.

13 CHAIRPERSON ANDERSON: All right.  
14 Good morning, sir. Thank you for being here.

15 MR. O'BRIEN: Which is why I gave the  
16 reporter the card.

17 CHAIRPERSON ANDERSON: All right.  
18 That's fine. That's fine. All right.

19 Ms. Phillips, are there -- this is a  
20 Status Hearing, a Show Cause Hearing (Status),  
21 are there any preliminary matters in this case?

22 MS. PHILLIPS: Yes, Mr. Chair, there

1 are. This is a two count case: Sale to Minor  
2 and Failure to Take Proper Identification.

3 It will be a warning as a fine for  
4 both charges. So it would be a warning for the  
5 first charge and a warning for the second charge.

6 CHAIRPERSON ANDERSON: Mr. O'Brien,  
7 it's my understanding that there is an Offer in  
8 Compromise and the Offer in Compromise is that  
9 for Charge 1 there is a warning and for Charge 2  
10 there is a warning. Is this your understanding  
11 of the Offer in Compromise?

12 MR. O'BRIEN: Yes, sir, it is.

13 CHAIRPERSON ANDERSON: And all right.  
14 Any questions by any Board Members?

15 Hearing none, I make a motion that the  
16 Offer in Compromise of a warning for Charge 1 and  
17 for a warning for Charge 2 be accepted.

18 Is there a second?

19 MEMBER SHORT: Second.

20 CHAIRPERSON ANDERSON: Mr. Short has  
21 seconded the motion.

22 All those in favor say aye.

1 ALL: Aye.

2 CHAIRPERSON ANDERSON: Those opposed?

3 The matter is passed 5-0-0.

4 I thank the parties for working this  
5 matter out. We will have you sign-off on this  
6 and it's -- you are free to go.

7 MR. O'BRIEN: All right. Thank you.

8 MS. PHILLIPS: Um-hum.

9 MR. DAMELINCOURT: Thank you very  
10 much.

11 MS. PHILLIPS: Thank you.

12 CHAIRPERSON ANDERSON: We are -- thank  
13 you. And we are in recess until our 1:30  
14 hearing. All right. Thank you.
