10	Attorney's Office.
11	CHAIRPERSON ANDERSON: Good morning,
12	Mr. Rivero.
13	MS. FLETCHER: Michele Fletcher, the
14	owner.
15	CHAIRPERSON ANDERSON: I'm sorry; your
16	name?
17	MS. FLETCHER: Michele Fletcher.
18	CHAIRPERSON ANDERSON: Ms. Fletcher.
19	MS. FLETCHER: Yes.
20	CHAIRPERSON ANDERSON: You have
21	appeared in front of me before, I believe.
22	MS. FLETCHER: Yes.

CHAIRPERSON ANDERSON: Are there any preliminary matters in this case?

MR. RIVERO: Yes, the parties have an offer in compromise to present to the Board at this time.

CHAIRPERSON ANDERSON: What is that offer in compromise, please?

MR. RIVERO: The offer consists of, for Charge 1, a fine of \$1,500, payable in 60 days, and for Charge 2, a fine of \$1,250, payable in 60 days, for a total of \$2,750. If the fine is not paid within 60 days, the license will be suspended until payment is received. That is the offer in compromise.

CHAIRPERSON ANDERSON: Ms. Fletcher, it's my understanding that there's an offer in compromise, and the offer in compromise is that for Charge 1, there's a fine of \$1,500 paid within 60 days, for Charge 2, a fine of \$1,250 paid within 60 days. If the fine is not paid within 60 days, the license will be suspended until the fine has been paid. Is this your

understanding of the offer in compromise? 1 2 MS. FLETCHER: Yes, it is, sir. CHAIRPERSON ANDERSON: 3 Are you aware 4 that by accepting an offer in compromise, you're giving up your right to a hearing? 5 6 MS. FLETCHER: Yes, sir. 7 CHAIRPERSON ANDERSON: Are you also aware that by accepting the offer in compromise, 8 9 you're giving up your right to appeal this 10 matter? 11 MS. FLETCHER: Yes. 12 CHAIRPERSON ANDERSON: With that said, I then make a motion that the fine -- for Charge 13 14 1, there's a fine of \$1,500 paid within 60 days, for Charge 2, a fine of \$1,250 payable in 60 15 16 days. If the total fine of \$2,750 is not paid 17 within 60 days, the license will be suspended 18 until the fine is paid. Is there a second? 19 MEMBER SHORT: Second. 20 CHAIRPERSON ANDERSON: Mr. Short has 21 seconded the motion. All those in favor say aye. 22 (Chorus of ayes.)
