4	on our Show Cause Hearing (Status) Calendar is

7	Will the parties, please, approach and
8	identify themselves for the record, please?
9	MR. RIVERO: Good morning, Board
10	Members. Fernando Rivero for the District of
11	Columbia.
12	CHAIRPERSON ANDERSON: Good morning,
13	again, Mr. Rivero. Yes, ma'am?
14	MS. FLETCHER: Michele Fletcher, owner
15	of Kyss Kyss.
16	CHAIRPERSON ANDERSON: Good morning,
17	Ms. Fletcher. All right. Are there any
18	preliminary matters in this case, sir?
19	MR. RIVERO: Yes, the parties have an
20	Offer in Compromise to present to the Board at
21	this time.
22	CHAIRPERSON ANDERSON: And what is the

Offer in Compromise, please? 1 2 MR. RIVERO: The offer is a fine of 3 \$350 payable in 30 days. And if the fine is not 4 paid in 30 days, the license will be suspended 5 until payment is received. CHAIRPERSON ANDERSON: All right. 6 7 Thank you. That is the offer. 8 MR. RIVERO: 9 CHAIRPERSON ANDERSON: Thank you. 10 Fletcher, it's my understanding that there is an 11 Offer in Compromise and the Offer in Compromise 12 is that there is a fine of \$350 payable in 30 13 days. If the fine is not payable in 30 days, the 14 license will be suspended. 15 Is this your understanding of the 16 Offer in Compromise? 17 MS. FLETCHER: Yes, it is, sir. 18 CHAIRPERSON ANDERSON: Are you aware 19 that by accepting an Offer in Compromise, that 20 you are giving up your right to appeal this 21 matter? I'm sorry, that you are giving up your

right to a hearing, are you aware of that?

8	Thank you. With that said, I make a motion that				
9	the Offer in Compromise of a fine of \$350 payable				
10	in 30 days be accepted. If the fine is not				
11	payable in 30 days, then the license will be				
12	suspended. Is there a second?				
13	MEMBER SHORT: Second.				
14	CHAIRPERSON ANDERSON: Mr. Short has				
15	seconded the motion.				
16	All those in favor say aye.				
17	ALL: Aye.				
18	CHAIRPERSON ANDERSON: All those				
19	opposed? The matter passes 6-0-0.				
20	Ms. Fletcher, I just want to ask you				
21	a simple question since the case is over. Can				
22	you explain to me the name? It's what I see is				

1	it's 12 Twelve DC/Kyss Kyss. So can you just			
2	explain to me the name, just for out of my own			
3	curiosity?			
4	MS. FLETCHER: Well, okay, no problem.			
5	It's two buildings 1212 H Street.			
6	CHAIRPERSON ANDERSON: Okay.			
7	MS. FLETCHER: And then 1210 H Street.			
8	1210 is a dessert bar. 1210 Kyss Kyss is a			
9	dessert bar.			
10	CHAIRPERSON ANDERSON: Okay.			
11	MS. FLETCHER: 1212 is a restaurant			
12	and lounge.			
13	CHAIRPERSON ANDERSON: Okay.			
14	MS. FLETCHER: So it's two buildings,			
15	two different addresses, so that's why you guys			
16	split it like that.			
17	CHAIRPERSON ANDERSON: Okay. All			
18	right. Okay. Since everything is repeated, I			
19	was just curious, but thank you very much, ma'am,			
20	for the all right.
