18 protest hearing status at 9:30 this morning. The
19 case was called. Neither the ANC or the licensee
20 was here. It is now 10 o'clock. The case has
21 been recalled and the ANC and the licensee is not
22 here.

23 I then make a motion that we dismiss
24 the renewal application and also dismiss the
25 ANC's protest of the renewal of the application.

3 CHAIRPERSON ANDERSON: Ms. Crockett
4 has seconded the motion. All in favor, say, aye.

5 (Chorus of ayes)

6 CHAIRPERSON ANDERSON: Those opposed.

7 The matter passes 4-0-0. Both the licensee and
8 the ANC will be provided ten days to give us
9 reason or notice why they were not here today.

10 If neither does that, then the license
11 application will be dismissed and the protest has
12 been dismissed at the same time too.
