9 License Renewal.

10 The protest issues are adverse impact
11 on peace, order and quiet, residential parking
12 and vehicular and pedestrian safety and real
13 property values.

15 the roll call hearing as the Board's agent.

18 MR. MARTIN: Good morning. Thomas
19 Martin, representing Ching, LLC, trading as
20 Uproar.

21 MS. FLETCHER: Mr. Martin, would you
22 spell your last name?

23 MR. MARTIN: M-A-R-T-I-N.

24 MS. FLETCHER: Oh, Martin.

25 MR. MARTIN: Yeah.

1 MS. FLETCHER: Thank you. And your
2 name, ma'am? If you could just state it and
3 spell it for the record?

4 MS. TRUONG: My name is Tammy Truong.
5 And it's T-A-M-M-Y; last name is T-R-U-O-N-G.

6 MS. FLETCHER: And what's the first
7 name?

8 MS. TRUONG: Tammy, T-A-M-M-Y.

9 MS. FLETCHER: Oh, Tammy? Okay, Mr.
10 Martin, are you representing the establishment?

15 Tuesday, February 11, if you like.

16 MS. NORMAN: Okay, thank you.

17 MS. FLETCHER: Mr. Martin, would
18 Tuesday, February 11, work for you that day?

19 MR. MARTIN: That's acceptable, yes.

20 MS. FLETCHER: Any time between 9:00
21 and 2:00?

22 MR. MARTIN: Whatever's most
23 convenient for the Board.

24 MS. FLETCHER: Okay. So, Ms. Norman,
