ORDER VACATING CANCELLATION OF LICENSE AND REINSTATING LICENSE

On November 18, 2020, the Alcoholic Beverage Control Board (Board) cancelled the Retailer Class CT License No. ABRA-078443 held by 915 U, LLC, t/a Velvet Lounge (Petitioner), because the Petitioner failed to pay the second year license fees. *See* Board Order No. 2020-801.

On August 11, 2021, Haile Berhane, on behalf of the Petitioner, sought reinstatement of the Retailer's Class CT License No. ABRA-078443. In support of its request for reinstatement, the Petitioner indicated that all issues preventing the Petitioner from submitting its second year license fees have been resolved.

The Board finds that the reinstatement of the license is proper conditioned upon the requirement that the Petitioner pays the second year license fees.

Accordingly, it is this 18th day of August 2021, **ORDERED** that the **ORDER CANCELLING LICENSE** issued against the Petitioner, by the Board on November 18, 2020, be and hereby is **VACATED**.

IT IS FURTHER ORDERED that its Retailer's Class CT License ABRA-078443 be **REINSTATED**.

IT IS FURTHER ORDERED that the Petitioner pay the required fees within two (2) weeks from the date of this Order.
