4	next case on our calendar is Case No. 18-CMP-
5	00011. We have a Fact-Finding Hearing on Vieux
6	Carre/For Rent, License No. 102576.
7	Are the parties here? I don't see the
8	Investigator. I don't neither do I see the
9	licensee, so is there anyone here for this case?
10	Can someone go find the Investigator,
11	please?
12	The next case on our calendar is case
13	we have a Fact-Finding Hearing on Vieux
14	Carre/For Rent, License No. 102576.
15	Will the parties, please, approach and
16	identify themselves for the record?
17	INVESTIGATOR TOWNSEND: Good morning.
18	Investigator Shawn Townsend.
19	CHAIRPERSON ANDERSON: Good morning,
20	Mr. Townsend.
21	I do not see the licensee here. All
22	right. It is my understanding that this matter

1	although our calendar says that the Fact-Finding
2	Hearing was scheduled for 10:00 a.m. this
3	morning, it's my understanding that the Agency
4	informed the licensee that the hearing would be
5	at 1:30 this afternoon. So we will then move
6	this case to 1:30.
7	All right. The Board then will be in
8	recess until our afternoon calendar. Thank you.
9	(Whereupon, the above-entitled matter
10	went off the record at 11:00 a.m. and resumed at
11	2:35 p.m.)
12	CHAIRPERSON ANDERSON: All right.
13	Moving on on our calendar, our next case is we
14	have a Fact-Finding Hearing on Vieux Carre/For
15	Rent, License No. 102576.
16	Would the parties, please, approach
17	and identify themselves for the record?
18	MS. LATIMER: Shawnequee Latimer.
19	CHAIRPERSON ANDERSON: Ms. Lavender?
20	MS. LATIMER: Latimer.
21	CHAIRPERSON ANDERSON: Latimer. There
22	is a sign-in sheet, please, sign your name in,

1	please.
2	Now, can who are you, sir? Are you
3	here for this case? Are you going to do you
4	have are you going to say something?
5	MR. TILLMAN: Yes, sir, I am.
6	CHAIRPERSON ANDERSON: No, you can
7	come up.
8	MR. TILLMAN: No problem.
9	CHAIRPERSON ANDERSON: When I call
10	everybody, everybody you pull a chair up and
11	sit at the table and introduce yourself and have
12	a seat.
13	MR. TILLMAN: Absolutely.
14	CHAIRPERSON ANDERSON: All right.
15	MR. TILLMAN: I'm going to sit. Thank
16	you.
17	CHAIRPERSON ANDERSON: Huh?
18	MR. TILLMAN: I'm going to sit.
19	CHAIRPERSON ANDERSON: You can pull
20	the chair up. There is a chair there if you
21	need. If you can sit, yeah. Whichever way,
22	whichever is more comfortable for you, sir.

1	MR. TILLMAN: Thank you.
2	CHAIRPERSON ANDERSON: All right.
3	Okay. State your name for the record. I'm
4	sorry, sir. I see you are making yourself
5	comfortable.
6	MR. TILLMAN: No, I can't put pressure
7	on my
8	CHAIRPERSON ANDERSON: That's what I'm
9	saying, you are making yourself comfortable.
10	State your name for the record, please, sir.
11	MR. TILLMAN: James Tillman.
12	CHAIRPERSON ANDERSON: Mr. Tillman.
13	MR. TILLMAN: With the Tillman Group.
14	CHAIRPERSON ANDERSON: And you, sir?
15	MR. JONES: Jermaine Jones from
16	Tillman Group.
17	CHAIRPERSON ANDERSON: Mr. Jones. And
18	you are Ms. Latimer. And introduce yourself for
19	the record, please.
20	INVESTIGATOR TOWNSEND: ABRA
21	Investigator Shawn Townsend.
22	CHAIRPERSON ANDERSON: Mr. Townsend.

1	Now, maybe I just want folks to just so who
2	are you, Ms. Latimer?
3	MS. LATIMER: I am the person that the
4	licensee is supposed to be transferred to.
5	CHAIRPERSON ANDERSON: Okay. So you
6	are
7	MS. LATIMER: It has not transferred
8	yet.
9	CHAIRPERSON ANDERSON: All right. So
LO	have we have you submitted a transfer
L1	application? Has there been a transfer
L2	application submitted to the Agency?
L3	MS. LATIMER: Yes.
L 4	CHAIRPERSON ANDERSON: And do you know
L5	when that was submitted?
L6	MS. LATIMER: December 5, 2017.
L7	CHAIRPERSON ANDERSON: And
L8	MS. LATIMER: That's when it was
L9	stamped in.
20	CHAIRPERSON ANDERSON: And so from
21	your perspective, what does that mean to you?
22	You have submitted a that's a transfer

	application, so what does that mean to you as far
2	as this business is concerned?
3	MS. LATIMER: That I don't even think
4	that I can make a decision until transfer the
5	license over to me.
6	CHAIRPERSON ANDERSON: And so can you
7	operate? Can you run the business?
8	MS. LATIMER: I can't do anything
9	without a license.
10	CHAIRPERSON ANDERSON: So you can't
11	run the business.
12	MS. LATIMER: No.
13	CHAIRPERSON ANDERSON: All right. All
14	right. And so we have Mr. Tillman and Mr. Jones,
15	so, Mr. Tillman and Mr who wants to speak
16	first on that? Mr. Jones?
17	MR. TILLMAN: I was going to speak.
18	CHAIRPERSON ANDERSON: So tell me what
19	is going on as far as this establishment and your
20	ownership, please.
21	MR. JONES: So formerly, Mr. Tillman
22	was the owner of Tillman Group, Vieux Carre. I

1	was the business manager, day-to-day operations
2	at Vieux Carre. July 31st of 2017 was our last
3	day of business. And since then, we have
4	attempted to transfer the liquor license to Ms.
5	Latimer.
6	CHAIRPERSON ANDERSON: Okay. So you
7	have attempted. What do you mean you have
8	attempted to transfer it to her since July?
9	MR. JONES: Mr. Tillman has submitted
LO	the paperwork necessary on his part for the
L1	transfer application to that award.
L2	CHAIRPERSON ANDERSON: So that was
L3	so July 31st. So what
L 4	MR. JONES: July 31st was the last day
L 5	that Mr. Tillman or myself was operating the
L6	actual space.
L7	CHAIRPERSON ANDERSON: All right. So
L8	is this place still open?
L9	MR. JONES: I have no idea. From what
20	we understand, apparently it has been, but not by
21	our account. We have not had it open.
22	CHAIRPERSON ANDERSON: So who has been

1	operating this place?
2	MR. JONES: It hasn't been us.
3	CHAIRPERSON ANDERSON: But and
4	before I go to all right. Okay. You own an
5	establishment. Okay? You have transferred it or
6	attempted to transfer it July 31st to another
7	owner.
8	MR. JONES: No, sir.
9	CHAIRPERSON ANDERSON: You ceased
10	operation on July 31, 2017?
11	MR. JONES: Correct.
12	CHAIRPERSON ANDERSON: So did you turn
13	the license back your license into the ABC
14	Board?
15	MR. JONES: So we have retained the
16	license. We hold the license. They called us
17	and asked us if we would like to an abeyance
18	or
19	MEMBER SHORT: Safekeeping.
20	MR. JONES: safekeeping.
21	MR. TILLMAN: We was going to put it
22	into safekeeping.

1	MR. JONES: They contacted us about
2	safekeeping.
3	CHAIRPERSON ANDERSON: Yes.
4	MR. JONES: We were making a
5	determination on whether or not there was going
6	to be some sort of sale of the business. We did
7	not have any viable buyers.
8	In November of last I'm sorry.
9	CHAIRPERSON ANDERSON: Yeah, go ahead.
10	All right. So you asked the Agency about
11	safekeeping. And so you ceased operations.
12	MR. JONES: Correct.
13	CHAIRPERSON ANDERSON: So what is
14	so what happened with the safekeeping request or
15	anything else?
16	MR. TILLMAN: Nothing. So actually
17	this Board, the Board actually suspended the
18	license, if I'm not mistaken, because we did not
19	renew it, because we weren't doing business.
20	CHAIRPERSON ANDERSON: When was that?
21	MR. JONES: This was I think October

1	license.
2	CHAIRPERSON ANDERSON: So you
3	MR. JONES: If you allow me, can I
4	give you I just want to give you the course of
5	action.
6	CHAIRPERSON ANDERSON: Yes, yeah. And
7	that's why I'm asking the question.
8	MR. JONES: It will be easier.
9	CHAIRPERSON ANDERSON: Right.
10	MR. JONES: So we were operating the
11	space up until July 31st of last year.
12	CHAIRPERSON ANDERSON: Right.
13	MR. JONES: We did an auction, sold
14	everything in the space, removed all the alcohol
15	from the space. Between July and November of
16	last year, we had no dealings with this space.
17	We did not have keys. The locks had been
18	changed. No one was operating in the space.
19	MEMBER ALBERTI: So have you moved the
20	alcohol you said?
21	MR. JONES: We have removed it and put
22	it in safekeeping.

1	MEMBER ALBERTI: Okay.
2	MR. JONES: Okay. So there was no
3	alcohol. There was all of the contents in the
4	space was removed. We sold everything.
5	Literally, the doors off some of the walls. So
6	we did an auction and sold everything. The place
7	was closed.
8	CHAIRPERSON ANDERSON: So that's
9	between July and?
10	MR. JONES: November of last year.
11	CHAIRPERSON ANDERSON: November, what
12	date, approximately?
13	MR. JONES: November 5th. I'm sorry,
14	it had to be the first week of November. I don't
15	want to give you an exact date.
16	CHAIRPERSON ANDERSON: All right.
17	MR. JONES: I can give you exact dates
18	on when some of the next part of my story has
19	been in terms of us doing transfers.
20	CHAIRPERSON ANDERSON: So about the
21	first week in November of 2017.
22	MR. JONES: Correct.

CHAIRPERSON ANDERSON: So where was 1 2 the license? Where was --3 MR. JONES: In our possession or in 4 Mr. Tillman's possession. It was not on 5 premises. CHAIRPERSON ANDERSON: 6 Okay. So you 7 had the physical license, because you had -- it 8 wasn't in safekeeping? 9 MR. JONES: Right. CHAIRPERSON ANDERSON: 10 But the -- we 11 had canceled it and you asked for reinstatement 12 and it was reinstated? 13 MR. JONES: No. So there is more to 14 the story between us asking for the reinstatement 15 and us closing down. So we had the license in our 16 17 possession. There was no operations going on. 18 In November of last year, we were contacted by an 19 Ajiboye interested in taking over the space. 20 They had worked out something with the landlord 21 and wanted to use the space. They reached out to We were interested in allowing them to 22

assume the business, so they could operate with the proper procedure for the transference of the license.

We called down to ABRA to speak to somebody to ask them what that procedure was. We spoke to Ms. Nicole Cullings, who gave us a series of things that we needed to do prior to transferring the license. We did all of those things.

We went down to DCRA and I have the documents here. We reinstated the business with DCRA. We did a transfer of the principal place of business. The governing member or authorized person for the business out of Mr. Tillman's name and into Ms. Latimer's name.

We went to OTR did the -- to use -got the corresponding documents. And then we
came to ABRA to ask what happens next. So we met
with Nicole Cullings in a conference room. She
met with myself, Mr. Tillman, Ms. Latimer. We
went through the entire procedure for what needed
to be done. She gave us a packet.

1	We took that packet downstairs, got
2	some things notarized. Ms. Latimer took the
3	packet back. We had to get a few other documents
4	signed and/or generated for her to finish the
5	documents.
6	They asked if we were interested in
7	operating during the transfer. We said no. Mr.
8	Tillman explicitly made it clear to Ms. Cullings
9	that we were not interested in operating
10	whatsoever.
11	MEMBER ALBERTI: Just when did that
12	happen, all of that you just described?
13	MR. JONES: This was on November the
14	15th.
15	MEMBER ALBERTI: So it wasn't in
16	September?
17	MR. JONES: No. Nothing happened in
18	September.
19	CHAIRPERSON ANDERSON: Things were
20	MEMBER ALBERTI: No, I someone
21	I thought I heard someone say that
22	CHAIRPERSON ANDERSON: No, no, no.

1	MEMBER ALBERTI: the transfer
2	started in September.
3	CHAIRPERSON ANDERSON: No, no, no.
4	MEMBER ALBERTI: Okay.
5	MR. JONES: No.
6	CHAIRPERSON ANDERSON: The business
7	was shutdown between July and
8	MEMBER ALBERTI: No, I understand.
9	CHAIRPERSON ANDERSON: November.
10	MEMBER ALBERTI: I understand. I just
11	wanted to make sure I had my timings right.
12	CHAIRPERSON ANDERSON: So
13	MEMBER ALBERTI: Okay.
14	CHAIRPERSON ANDERSON: they weren't
15	operating.
16	MEMBER ALBERTI: I know.
17	CHAIRPERSON ANDERSON: All right. So
18	about November 15th you met with the Agency?
19	MR. JONES: Correct.
20	CHAIRPERSON ANDERSON: Okay. Go
21	ahead.
22	MR. JONES: So we started that

transfer process. We filled out the application, sent all the corresponding documents in. I think we had a new operating agreement established for Tillman Group now that we had changed ownership giving Ms. Latimer full control of the business and removing Mr. Tillman.

We asked Ms. Cullings, at that time, if in fact there were operations that still went on, would Mr. Tillman be held liable for violations, for any issues that may arise. She informed us that he would. We made it very clear that we did not want that to happen. We kept the license and we asked for Ms. Cullings and ABRA not to issue anybody any copies or any other parts of the license.

And as far as we know, outside of that, Ms. Latimer was and, as far as we know, has submitted an application for transfer and that is the furthest that our involvement goes.

CHAIRPERSON ANDERSON: So why are you here today?

MR. JONES: Mr. Tillman asked me to be

1	here. We were, I think, summoned to be here.
2	CHAIRPERSON ANDERSON: Oh, well, yeah.
3	So why are you here today, Mr. Tillman? You told
4	me that you shut your business down. You closed
5	the doors on July 30th July 31st. You
6	nothing happened. You started the transfer, so
7	why are you here today?
8	MR. TILLMAN: We are here because we
9	just wanted to make sure once we turned in the
10	license, that our, I guess, part in the business
11	was done.
12	CHAIRPERSON ANDERSON: But
13	MR. TILLMAN: And
14	CHAIRPERSON ANDERSON: Go ahead, go
15	ahead.
16	MR. TILLMAN: so what I did, I
17	reached out to Inspector Shawn
18	CHAIRPERSON ANDERSON: Right.
19	MR. TILLMAN: and gave him the
20	license and told him he has to turn it in.
21	CHAIRPERSON ANDERSON: Right.
22	MR. TILLMAN: And I just wanted to

1	make sure that we had no more dealings with the
2	business at all.
3	CHAIRPERSON ANDERSON: Right. So you
4	don't know about anything that so is there
5	some operation in this establishment, in this
6	building? Do you know anything about that?
7	MR. TILLMAN: We do not.
8	CHAIRPERSON ANDERSON: You don't know
9	nothing?
10	MR. TILLMAN: We do not.
11	CHAIRPERSON ANDERSON: So you don't
12	even know why you are here today?
13	MR. TILLMAN: Well, we understand that
14	there was apparently some sort of violation
15	CHAIRPERSON ANDERSON: So I'm asking
16	you
17	MR. TILLMAN: that occurred. Oh,
18	yeah, but
19	CHAIRPERSON ANDERSON: so what do
20	you know?
21	MR. TILLMAN: We don't in all
22	honesty, we don't know the details of it, because

1	we were not involved. So we don't know. All we
2	know is apparently we that there was a
3	violation. They went into the space. Someone
4	was operating. Someone was posing or apparently
5	had something to do with Tillman Group. We are
6	here to make clear what Tillman Group's
7	involvement is and is not.
8	CHAIRPERSON ANDERSON: I know that.
9	The reason why is because I'm going to have Mr
10	I'm going to you. I'm not even with Mr. Townsend
11	yet. So I'm asking you guys from your
12	perspective.
13	MR. TILLMAN: What happened was my
14	assistant, Lisa
15	CHAIRPERSON ANDERSON: Is she here?
16	MR. TILLMAN: She is right there.
17	CHAIRPERSON ANDERSON: Tell her to
18	come on up.
19	MR. TILLMAN: Come on up, Lisa.
20	CHAIRPERSON ANDERSON: And give her
21	name for the record and everybody sign-in.
22	MR. TILLMAN: May I finish?

CHAIRPERSON ANDERSON: Yeah. 1 So she 2 can introduce herself and yeah. So my assistant sent me 3 MR. TILLMAN: 4 -- she contacted me and she said "James, is your establishment open?" I said "No, it's closed." 5 She said "Well, I received a flyer saying that 6 7 they having parties at your establishment." 8 said "I don't know anything about it. It's not 9 us." And I left it as that. I reached out to my friend, Shawn, and 10 11 I said who is having parties at this 12 establishment? It's not us. He said I don't So I left it at that with him. He went 13 know. 14 down and investigated and that was it. 15 CHAIRPERSON ANDERSON: So you don't 16 know who is having parties at --17 MR. TILLMAN: I do not. 18 CHAIRPERSON ANDERSON: -- so and I'm 19 going to ask some questions to ask you, because 20 once Mr. Townsend gives his report, then there is 21 a question that I'm going to ask about something that's important. 22

1	Yes, go ahead, Mr. Alberti.
2	MEMBER ALBERTI: So I want to so
3	just on what I'm sorry, your name again, sir?
4	MR. JONES: Jermaine Jones.
5	MEMBER ALBERTI: Mr. Jones, just sort
6	of the rendition that you gave, I have several
7	questions.
8	MR. JONES: Okay.
9	MEMBER ALBERTI: First of all, you
10	said in October you let the the license was
11	suspended for non-payment, correct?
12	MR. JONES: Correct. Don't quote us
13	on the dates in terms of what day it was.
14	MEMBER ALBERTI: Well, that would have
15	been about right.
16	MR. JONES: Right.
17	MEMBER ALBERTI: All right. All
18	right.
19	MR. JONES: Correct.
20	MEMBER ALBERTI: That's cool. We're
21	cool. Then you said it was you came down and
22	you had it reinstated.

1	MR. JONES: We did not.
2	MEMBER ALBERTI: Who did?
3	MR. JONES: We authorized for it to be
4	reinstated, because we could not apply for a
5	transfer.
6	MEMBER ALBERTI: How did you authorize
7	for it to be reinstated?
8	MR. JONES: We wrote a letter which I
9	have a copy of if you would like to see.
10	MEMBER ALBERTI: To?
11	MR. JONES: TO ABRA.
12	MEMBER ALBERTI: Asking that
13	MR. JONES: To this Board asking this
14	Board to, please, reinstate the license.
15	MEMBER ALBERTI: And was it?
16	MR. JONES: Yes, it was.
17	MEMBER ALBERTI: Okay. And that would
18	have been sort of the November time frame?
19	MR. JONES: Yes, sir.
20	MEMBER ALBERTI: Okay. Before or
21	after you had discussions with Ms. Latimer?
22	MR. JONES: This was when we had

1	after we had discussions with Ms. Latimer. We
2	actually didn't even know that the license was
3	canceled. When we came down to start the
4	transfer process, that is when Ms. Cullings
5	informed us that it was, in fact, suspended.
6	MEMBER ALBERTI: Okay.
7	MR. JONES: And we couldn't even begin
8	that process until we had reinstated it.
9	MEMBER ALBERTI: Then the Board
10	reinstated it. Meanwhile, you were having
11	discussions with Ms. Latimer?
12	MR. JONES: Correct.
13	MEMBER ALBERTI: Correct?
14	MR. JONES: Correct.
15	MEMBER ALBERTI: All right. You said
16	that you removed everything from the
17	establishment, closed it completely down. Took
18	all of the alcohol out, right?
19	MR. JONES: Correct.
20	MEMBER ALBERTI: Some of the
21	furnishings?
22	MR. JONES: Everything.

1	MR. TILLMAN: Everything.
2	MEMBER ALBERTI: Everything.
3	MR. JONES: Everything.
4	MEMBER ALBERTI: All right. Did you
5	rent this establishment?
6	MR. JONES: We did.
7	MEMBER ALBERTI: All right.
8	MR. JONES: We were renting it.
9	MEMBER ALBERTI: Were you still the
10	rentee or the lessee in November and after
11	November?
12	MR. JONES: We yes. We were on the
13	we are on the lease, yes.
14	MEMBER ALBERTI: Until when?
15	MR. JONES: The lease is a 10-year
16	lease, so I think we may have eight years left on
17	the lease.
18	MEMBER ALBERTI: Okay. So you were
19	technically still on the hook. You are still the
19 20	technically still on the hook. You are still the lessee?

1	someone else, besides Mr. Tillman or his
2	authorized personnel, get access to the
3	establishment?
4	MR. JONES: Got it. So it is our
5	understanding that the person apparently,
6	Ajiboye, who was a part of the violation went to
7	the rental office, made a payment towards our
8	back rent and worked out some sort of deal to get
9	access to the space.
LO	MEMBER ALBERTI: So he so somebody
L1	who we will hear about later
L 2	MR. JONES: Right.
L3	MEMBER ALBERTI: he went
L 4	MR. JONES: To the landlord.
L 5	MEMBER ALBERTI: directly to the
L6	landlord without your authorization.
L 7	MR. JONES: Correct.
L8	MEMBER ALBERTI: And the landlord
L9	accepted his representation?
20	MR. JONES: Well, I imagine so,
21	because upon our closing, we turned our keys into
22	the landlord, were two months behind on rent and

1	figuring out a settlement to get out of our lease
2	with him.
3	MEMBER ALBERTI: Oh, so even if you
4	had
5	MR. JONES: Yeah, we were like done,
6	done.
7	MEMBER ALBERTI: Okay.
8	MR. JONES: That's why we did the
9	auction.
10	MEMBER ALBERTI: So it's your
11	contention that the landlord then gave the keys
12	to someone who then gained access to this
13	establishment?
14	MR. JONES: We are certain. Well, the
15	keys we had didn't even work any more. They keys
16	were the locks were changed.
17	MEMBER ALBERTI: Prior to
18	MR. JONES: We didn't have
19	MEMBER ALBERTI: by the landlord?
20	MR. JONES: On the last day of our
21	closing when we left, we turned in the keys and
22	the locksmith was changing the locks.

1	MEMBER ALBERTI: Okay. Very
2	interesting.
3	CHAIRPERSON ANDERSON: All right.
4	MEMBER ALBERTI: Did you make Ms.
5	Latimer aware of this?
6	MR. JONES: No.
7	MEMBER ALBERTI: No. Okay. So was it
8	your impression she was going to have to deal
9	with the landlord to get access to this
10	establishment?
11	MR. JONES: We weren't really
12	concerned with how she was getting access to the
13	establishment, only because her reaching out to
14	us or our interaction was purely around assuming
15	the business, thus for the transfer of the liquor
16	license to operate properly.
17	MEMBER ALBERTI: Okay. So Tillman
18	Group, LLC

2	members of Tillman Group, LLC?

7	documentation to show that that happened?
8	MR. JONES: Yes. I actually have
9	seven copies.
10	MEMBER ALBERTI: Have you given it to
11	us at all? I don't see it in our records.
12	MEMBER SHORT: And when
13	CHAIRPERSON ANDERSON: You are going
14	to she will take it from you.
15	MR. JONES: All right.
16	MEMBER ALBERTI: I guess there would
17	be a bill of sale or something like that? You
18	know, the things I have seen is that you are
19	giving this business over to Ms. Latimer for no
20	cost?
21	MR. JONES: No cost.
22	MEMBER ALBERTI: All right. So do we

have like a sales agreement or a summary to show the percentage of interest?

MR. JONES: No, because again, it was not a sale, so we allowed her to just assume the business by -- our intent was to file an amendment to our organization documents and allow her to assume governing the actual LLC and remove Mr. Tillman.

on November 15th and got all this done. We actually went to DCRA last Friday to make certain that this was, in fact, what they had on file. When we went there, they printed us out the exact same documents that you are looking at right now, made it clear to us that Ms. Latimer was, in fact, the governing officer for Tillman Group.

11	MEMBER ALBERTI: It lists Ms. Latimer
12	as a general member and it lists Mr. Tillman as a
13	general member. Why would that be if Mr. Tillman
14	is now
15	MR. JONES: Which document are you
16	referring to?
17	MEMBER ALBERTI: relinquishing all
18	interest in this LLC, why is he on this operating
19	agreement as a general member?
20	MR. JONES: So based on a
21	conversation, which I also have printouts of with
22	Ms. Latimer, apparently when Ms. Latimer filed

1	the original operating she was providing for
2	the Board all the necessary documents to complete
3	the transfer. And the specialist, she was
4	working with Ms. Cullings, asked her for an
5	operating agreement and it was to have any or
6	include all this information.
7	When we initially filed it and you
8	will see and if you would like, I can give you
9	copies.
10	MEMBER ALBERTI: Back in November was
11	Mr. Tillman still part of the LLC?
12	MR. JONES: Up until November 15th,
13	yes, sir.
14	MEMBER ALBERTI: Until November 30th.
15	MR. JONES: Up until November 15th.
16	MEMBER ALBERTI: You said November
17	30th and I have an operating agreement that lists
18	him as a general member.
19	MR. JONES: Because that

And when we submitted --6 7 MEMBER ALBERTI: So in an operating 8 agreement, we only expect to see the members 9 discussed. I mean an operating agreement is between the members of the LLC. 10 11 MR. JONES: I completely understand. 12 MEMBER ALBERTI: According to what you 13 are telling me and I believe Ms. Latimer probably 14 will tell me the same thing is that on November 15 30th, she was the sole owner of this LLC, 16 correct? 17 MR. JONES: Yes, sir. MEMBER ALBERTI: 18 And you told me that 19 you took care of this with DCRA before November 20 13th. So why am I seeing Mr. Tillman still listed as a member of the LLC on November 30th? 21 22 MR. JONES: Because that's what was

8	the contact or did you contact him?
9	INVESTIGATOR TOWNSEND: Yes, he
10	initiated
11	CHAIRPERSON ANDERSON: Okay.
12	INVESTIGATOR TOWNSEND: the
13	contact.
14	CHAIRPERSON ANDERSON: All right.
15	MEMBER SHORT: What date was that?
16	MEMBER ISAAC: What was the date
17	again?
18	INVESTIGATOR TOWNSEND: I spoke to Mr.
19	Tillman on January 5th.
20	CHAIRPERSON ANDERSON: Okay.
21	INVESTIGATOR TOWNSEND: '18. And he
22	asked me about the operations at Vieux and if I

was aware if anyone was operating on this
particular evening. I told him I didn't. But I
did mention that I would go by there and see if
something was going on.

So during -- approximately, 11:00 p.m. while monitoring in that block, I can see Sound Check is an establishment directly across the street from Vieux Carre. And from standing -- as I was standing in front of Sound Check, I can see that there was some movement, some lights going on inside of Vieux.

So I entered along with Investigator
Kevin Puente and Mark Brashears. I was
approached by -- I'm sorry, I'll back up.
Immediately as I entered, I noticed that from my
previous visits at this establishment, the
alcohol license is usually posted on the left,
left column, along with the Certificate of
Occupancy, the business license, etcetera.

And in place of the alcohol license was a receipt, was an ABRA receipt and I immediately, you know, flashed my light on it to

see what it was. And from what -- at the moment what I assumed was, based on knowledge that I had of the transfer situation after speaking with Ms. Cullings is that, that this was a renewal receipt that someone had paid to reinstate the license. This is my assumption at the moment.

So I was approached by Mr. Ajiboye

Laosebikan. For this testimony's purpose, I'm

going to refer to him as Aji, which is his common

name of -- from what I understand.

He presented me with an ABC Manager's License. I immediately pointed out to Aji that the -- I noticed a receipt on the wall and I asked him where the alcohol license was. And Aji stated to me that the ABC License was paid in full and that he assumed that he can use the receipt as proof that the establishment was properly licensed until the Board had approved the transfer of the license.

At that point, I started to question

Aji about who he was representing at the

establishment that evening and he stated that he

was representing the new ownership. And I mentioned Ms. Latimer's name and he said yes, he was representing Ms. Latimer under the new Tillman Group, so to speak.

I asked him, you know, how is that possible, because I was made aware that Mr.

Tillman was still in possession of the actual, the physical alcohol license and he reiterated to me that he assumed that because --

CHAIRPERSON ANDERSON: Hold on. Do they have a copy of your report?

MR. JONES: No, we do not.

CHAIRPERSON ANDERSON: Okay. We will give you a copy. I see you are stretching, so that was an indication to me that you have no idea what he is talking about. All right. Go ahead, Mr. Townsend.

INVESTIGATOR TOWNSEND: Thank you. So I informed him, I informed Aji that although the renewal was paid on the license, the transfer was -- had not been approved by the ABC Board at that time. And he, Aji, specifically told me that he

was both a former employee of Mr. Tillman and now a current employee of the new owner, Ms. Latimer, so he assumed that he could operate in the establishment by using this receipt.

I informed him that it was a violation because the establishment was operating without an ABC License present. And then also, there were -- he couldn't answer my questions related to the alcohol that was being served by bartenders, where it was purchased. He once stated that the -- that Mr. Tillman, in fact, still had the invoices for the alcohol, but you just heard his testimony -- their testimony and they stated that the alcohol was --

MEMBER SHORT: In safekeeping.

INVESTIGATOR TOWNSEND: -- removed from the establishment prior to them closing. So I ended up making contact with Ms. Latimer on Tuesday, January 9th, and informed her of the violation that occurred on Friday, January 5th, and also mentioned to her that Aji stated that he was representing the new ownership of the

establishment.

Ms. Latimer stated that she had not been approved by the ABC Board as a new owner and advised me that I should contact Mr. Tillman, because he was the still the owner of the establishment pending the approval of the transfer of the license.

MEMBER SHORT: What date was that?

INVESTIGATOR TOWNSEND: I'm sorry?

January 9, 2018.

I attempted to explain to Ms. Latimer that Mr. Tillman had advised ABRA not to issue this establishment a copy of the license until the transfer was complete. And she pretty much told me that I needed to contact Mr. Tillman, because he was still the owner on file at this establishment.

I did pull up some flyers, which are included as exhibits, from social media for events taking place at the establishment, at Vieux. I did confirm with licensing on January 9th as well that the transfer application packet

1 was still pending. It had not been approved yet 2 by the Board. I contacted Mr. Tillman also on that 3 4 Tuesday, January 9th, and he stated that he 5 transferred the business to Ms. Latimer in November of 2017 and was no longer involved in 6 7 the operations. Mr. Tillman did state that he 8 had the ABC License in his possession, because he 9 didn't want the establishment to operate until the transfer was complete. 10 11 Just a point of reference, Mr. Aji is 12 an ABC Manager that I have dealt with at an 13 establishment on H Street, N.E., Da Luft. At the 14 time, he presented a fraudulent ABC Manager's License to me during a regulatory inspection and 15 16 was issued a new ABC Manager's License that expires in 2019. 17 18 CHAIRPERSON ANDERSON: When -- so it's 19 -- oh, it's 2019, okay. That's all? 20 INVESTIGATOR TOWNSEND: Yes, sir. 21 CHAIRPERSON ANDERSON: All right. Now, Mr. Davis? 22

5	MEMBER ALBERTI: Can we pause? I need
6	some I would like to get some records from
7	licensing.
8	CHAIRPERSON ANDERSON: Yeah, I mean
9	MEMBER ALBERTI: So I'm going to do it
10	right now.
11	CHAIRPERSON ANDERSON: we are going
12	to
13	MEMBER SHORT: I have one question.
14	CHAIRPERSON ANDERSON: Yes, yes.
15	MEMBER SHORT: I would like to ask Mr.
16	Jones and Mr. Tillman, you said that when you
17	stopped operating in July, you took all the
18	alcohol.
19	MR. JONES: Yes, sir.
20	MEMBER SHORT: Do you have any proof
21	of where you took it and where you stored it?
22	Any proof at all?

1	MR. JONES: I mean, I have the receipt
2	from the storage unit, which we were storing it
3	all, most of it in, yes. I mean, we transferred
4	it from the location along with
5	MEMBER SHORT: Is the alcohol still
6	there now?
7	MR. JONES: It is not unfortunately.
8	We
9	MEMBER SHORT: Oh. So what happened
10	to the alcohol that you had taken out of the
11	club?
12	MR. JONES: We gifted it over the
13	course of the last
14	MEMBER SHORT: You gifted it to whom?
15	MR. JONES: Friends, family.
16	MEMBER SHORT: So
17	MR. JONES: We had to get rid of
18	storage.
19	MEMBER SHORT: could it have wound
20	up back in the club?
21	MR. TILLMAN: No.
22	MR. JONES: There is no way possible.

1	MR. TILLMAN: No.
2	MR. JONES: Furthermore, just because
3	I would like to expedite part of the your
4	Fact-Finding Hearing, I have correspondence with
5	Aji and Ms. Latimer that shows us communicating
6	with them, them asking us for permission directly
7	not them, Ms. Latimer asking permission for
8	Mr. Tillman to authorize us to operate, us
9	denying them, telling them that we cannot and
LO	will not.
L1	CHAIRPERSON ANDERSON: Where is all of
L2	this? Where is it?
L3	MR. JONES: Right here.
L 4	CHAIRPERSON ANDERSON: Can you give
L5	that to us, please?
L6	MEMBER ALBERTI: I'll get it.
L7	CHAIRPERSON ANDERSON: And we are
L8	going to take a break, but I during the recess
L9	I mean, the fact the purpose of a Fact-
20	Finding Hearing is to get information. And what
21	I'm saying and my concern more so is with you,

Ms. Latimer. You are asking us to approve you,

1	to give you a license.
2	MS. LATIMER: Right.
3	CHAIRPERSON ANDERSON: And I can't
4	have you saying I don't know. You are asking us
5	to give you this license that Mr. Aji is
6	operating. And you can't tell us
7	MS. LATIMER: Um-hum.
8	CHAIRPERSON ANDERSON: I don't know
9	who Mr. Aji is. I don't know why he is
10	representing me. I mean, Mr. Tillman
11	MS. LATIMER: I never said I didn't
12	know who he was.
13	CHAIRPERSON ANDERSON: Well, but
14	MS. LATIMER: I said he
15	CHAIRPERSON ANDERSON: this is what
16	I'm getting. Whether or not all right. This
17	is where I'll start. Mr. Tillman stated he is
18	not an employee. He is a promoter. He just said
19	that.
20	MS. LATIMER: Right.
21	CHAIRPERSON ANDERSON: We asked you
22	and you said that oh, he is an employee of Mr.

Tillman. And that's -- and then -- I mean, I believe that -- I mean, say if you are making a determination, I mean, I'm -- Mr. Tillman and Mr. Jones as they are presented by their -- they are giving it the way it is.

This matter started -- we would not have known about it, about what was going on here, but not for the fact that Mr. Tillman contacted the Investigator to go figure it out, because this place would have been operating and we don't know.

Now, in this place, is there -- is this place still open?

MR. JONES: Just to be clear, the text messages are from me to Ms. Latimer and the second -- the first two pages are from me to a group chat speaking to Ms. Latimer and Aji. The final page is me speaking directly with Ms. Latimer. My information on the right, hers on the left.

CHAIRPERSON ANDERSON: What do you do for a living, Mr. Jones?

1	MR. JONES: I work for Mr. Tillman.
2	I'm a businessman.
3	CHAIRPERSON ANDERSON: I don't not
4	from that perspective, it's from the perspective
5	that you have paper. You have a paper trail,
6	that's it's on that perspective.

9	perspective I'm saying that I have basically
10	not gotten on a hearing where people got paper
11	trails and that's I'm giving you a compliment.

16	business didn't work out for us.

18	paper trail to
19	MR. JONES: Yeah, yeah.

21	take a short break recess. Now, she wants to say
22	something.

15	you agree with that?
16	MS. LATIMER: That's my understanding,
17	yes.
18	MEMBER ALBERTI: And when did you
19	become sole member of this LLC?
20	MS. LATIMER: In November.
21	MEMBER ALBERTI: In November?
22	MS. LATIMER: Um-hum, November 30th is

1	when we signed the operating agreement.
2	MEMBER ALBERTI: All right. Do you
3	have any knowledge of someone getting the keys to
4	this?

8	your proposed business?

3	relationship with the Tillman Group.
4	MEMBER ALBERTI: He has no
5	relationship to you?
6	MS. LATIMER: No.
7	MEMBER ALBERTI: Have you you have
8	not paid him in any you have not paid him for
9	anything?
10	MS. LATIMER: No.
11	MEMBER ALBERTI: Okay. Did you have
12	knowledge of the fact that he was going to be at
13	the establishment in January?
14	MS. LATIMER: I did not.
15	MEMBER ALBERTI: Okay. Well, I think
16	at some point, Mr. Chairman, we will discuss this
17	in the back, but I think we can have
18	CHAIRPERSON ANDERSON: No, we are
19	MEMBER ALBERTI: Mr. Laosebikan
20	come in at some point.
21	CHAIRPERSON ANDERSON: No, we I
22	think, Mr. Tillman, I see you have a nice smile

1	on your face. So you want to share with
2	MR. TILLMAN: Yeah, yeah.
3	CHAIRPERSON ANDERSON: us, please?

8	postings on social media.

10	seen. All right.
11	MR. JONES: I have. There is a flyer
12	for February 4th, so there is an event upcoming
13	February 4th. We have no involvement with.
14	CHAIRPERSON ANDERSON: Mr. Townsend?
15	No, he said he doesn't know.
16	MEMBER ALBERTI: You don't know of any
17	further activity at this establishment?
18	INVESTIGATOR TOWNSEND: No, sir.
19	CHAIRPERSON ANDERSON: Can you also
20	email that flyer to his email address?
21	MR. JONES: Absolutely.
22	CHAIRPERSON ANDERSON: I'm going to

end this hearing. I think this is a dog and pony 1 2 I'm sorry. This is what I will say. show. is a Fact-Finding Hearing and there are -- and 3 especially for you, Ms. Latimer, you are asking 4 5 us to give you a liquor license. 6 MS. LATIMER: Um-hum. 7 CHAIRPERSON ANDERSON: And so you are 8 in the process of getting -- for the Board to 9 transfer to us. And --Can we ask her for 10 MEMBER ALBERTI: her lease for this establishment? 11 12 Ms. Latimer, do you have a lease for this location? 13 14 CHAIRPERSON ANDERSON: I assume that--MS. LATIMER: No. I refused -- I 15 16 can't -- no, I don't have a lease. I was waiting 17 on this to go through first before I get a lease. 18 CHAIRPERSON ANDERSON: So why didn't 19 you -- so when you submitted a transfer, the 20 lease was not a -- a lease is not something that was required as part of the transfer application? 21 22 MS. LATIMER: No. I think that we--

22	name of your firm again? I missed the name of
