3 CHAIRPERSON ANDERSON: The next case
4 on our protest hearing status is Case Number 19-
5 PRO-00126, Wet Dog Tavern, License Number 96176.
6 Will the parties please approach and identify
7 themselves for the record, please.

8 MR. KLINE: Good morning, Andrew
9 Kline, on behalf of the Applicant.

10 CHAIRPERSON ANDERSON: Good morning,
11 Mr. Kline. I see that the ANC is not here. What
12 I will do, Mr. Kline, I will --

13 MR. KLINE: If I may, I would also
14 note that mediation was scheduled last Thursday
15 and was confirmed just two days before the
16 mediation, and the Applicant and I were there,
17 and the ANC failed to appear.

18 We have a formal motion that's
19 pending, but we're here and they're not here
20 again, so at this point, based on their failure
21 to appear at the mediation and their failure to
22 appear timely today, we would respectfully
23 request that the protest be dismissed.

24 CHAIRPERSON ANDERSON: What I was
25 going to do, Mr. Kline, is that as I normally do,

1 I normally start these hearings at 9:30, and then
2 I go through the calendar and recall, so what I
3 was going to do is to go through the protest
4 hearing status calendar, and if they're not here,
5 I will then, prior to the moving to the show
6 cause, which should be 10 o'clock, I will recall
7 the case.

8 And once the case is recalled and if
9 they're not here, then I would -- you'll have to
10 make the motion, then we'd automatically -- well,
11 in this particular case, it might be a little bit
12 different.

13 All right. So I will recall that case
14 shortly.

15 MR. KLINE: Great. Thank you.

16 CHAIRPERSON ANDERSON: You're welcome.

17 (Whereupon, the hearing in the above-
18 entitled matter was concluded at 9:57 a.m.)

19 CHAIRPERSON ANDERSON: Then let me
20 recall Case Number 19-PRO-00126, Wet Dog Tavern,
21 License Number 96176. Will the parties please
22 approach and identify themselves for the record,
23 please.

24 MR. KLINE: Andrew Kline, for the
25 Applicant.

1 CHAIRPERSON ANDERSON: Good morning,
2 Mr. Kline.

3 MR. KLINE: Good morning.

4 CHAIRPERSON ANDERSON: This matter was
5 scheduled for a protest hearing status at 9:30
6 a.m. The case was called and the licensee was
7 here and the protestant has failed to appear. It
8 is now 10:01. I've recalled the case and the
9 protestant has failed to appear.

10 Because this case is a little bit
11 different, Mr. Kline, what is your -- do you want
12 us to address your larger issue or should the --
13 should we just dismiss it?

14 MR. KLINE: At this point, just
15 dismiss it.

16 CHAIRPERSON ANDERSON: All right.
17 Then I make a motion -- I then make a motion to
18 the Board that the ANC's protest be dismissed.
19 Is there a second?

20 MEMBER SHORT: Second.

21 MEMBER CROCKETT: Second.

22 CHAIRPERSON ANDERSON: Ms. Crockett
23 and Mr. Short has seconded the motion. All those
24 in favor, say, aye.

25 (Chorus of ayes)

1 CHAIRPERSON ANDERSON: Those opposed.
2 The matter passes 4-0-0. What this means is
3 that, the ANC will be given ten days to give
4 reasonable notice why they were not here today.
5 If not, their protest will be dismissed.

6 Thank you very, Mr. Kline.

7 MR. KLINE: Thank you. Have a good
8 day.
