6	Hearing (Status) Calendar is Case No. 18-CMP-
7	00138, Woodley Café, License No. 76441.
8	Would the parties, please, approach
9	and identify themselves for the record, please?
10	MS. KRUPKE: Good morning, Jessica
11	Krupke on behalf of the Government.
12	CHAIRPERSON ANDERSON: Good morning,
13	Ms. Krupke.
14	MR. KHAIRZADA: Farid Khairzada. I'm
15	the owner of Woodley
16	CHAIRPERSON ANDERSON: I'm sorry, I
17	did not hear your last name, sir.
